

## **Bastrop ISD SHAC Annual Report for 2024-25**

In accordance with TEC 28.004 and HB3908 of the 88th Legislative Session, the 2025-26 SHAC recommends instruction on the dangers of opioids, including addiction to and abuse of synthetic opioids like fentanyl:

- Educational resources provided by the Texas A&M University Opioid Task Force ([txopioidaction.org](http://txopioidaction.org)) and Texas Health and Human Services ([One Pill Kills](#)) will be used with students in Grades 6-12 during Red Ribbon Week events, conducted in schools annually during the last week of October, when heightened emphasis is placed on encouraging students to resist peer pressure, avoid the use of dangerous and illegal substances, and make healthy, responsible choices.

### **Meetings Held During the Prior School Year**

The 2024-25 Bastrop ISD SHAC satisfied the TEC 28.004 requirements of convening a minimum of four times during the school year, on September 24, 2024; October 29, 2024; February 4, 2025; and April 1, 2025.

### **Instruction on Child Abuse, Family Violence, Dating Violence, and Sex Trafficking**

In accordance with TEC 28.004 and SB9 of the 87th Legislative Session, the 2025-26 SHAC recommends instruction on child abuse, family violence, dating violence, and sex trafficking. This recommendation is to renew all instructional materials and methods from the 2024-25 academic year, as follows:

- **Elementary (K-5th Grade):** Elementary students will receive instruction on the prevention of child abuse and family violence only. Required curriculum to use for students with parent/guardian consent: [CPU- Second Step Child Protection Unit](#)
- **Middle School (6th-8th Grade):** Middle School students will receive instruction on the prevention of child abuse, family violence, dating violence, and human trafficking. Additional curriculum is available through Edgenuity, with which the district is already

contracted. nRequired curriculum to use for students with parent/guardian consent:

**CAC- MS Children's Advocacy Center of North Texas**

- **High School (9th-12th Grade):** High School students will receive instruction on the prevention of child abuse, family violence, dating violence, and human trafficking. Additional curriculum is available through Edgenuity, with which the district is already contracted. Required curriculum to use for students with parent/guardian consent:

### **Bastrop ISD Wellness Plan**

During the 2024-25 school year, the SHAC worked with the child nutrition department to complete a full evaluation and review of the Bastrop ISD Wellness Plan (Policy FFA–LOCAL) to ensure all elements were aligned with Section 9A(a) of the National School Lunch Act (NSLA), 42 U.S.C. 1758b. The updated plan will remain in effect until the 2030-31 school year.

### **Toyota Way Forward Initiative**

Bastrop ISD is honored to be named a recipient of the prestigious Toyota Way Forward Pediatric Traumatic Brain Injury (TBI) grant with community partners Lost Pines Toyota and Ascension Catholic Church. Bastrop is only the third recipient in the nation of this grant, and the first educational institution. During the 2024 fall semester, the Bastrop ISD SHAC selected student ambassadors Brady Brewer and Charles Hamrick to represent the district in our concerted efforts to increase awareness, prevention, and early response to pediatric TBI events. Lost Pines Toyota hosted the Toyota Way Forward Kick-Off event for the Bastrop community in October 2024, featuring the Bastrop ISD Ballet Folklórico dancers, where community health partners, including Bastrop ISD medical director Dr. Pompeyo Chavez, provided information to Bastrop families on the risks of pediatric TBI, as well as the importance of daily prevention, including the use of seat belts and properly-fitted helmets during physical activity. Families were also provided with information about recognizing early warning signs of a severe head injury, and what steps to take in order to seek appropriate medical assistance promptly. Bastrop ISD athletic trainers received assistive technology through Toyota Way Forward grant funds that capture real-time brain scans. When student-athletes sustain a concussion, these scans are printed and provided to medical personnel to aid in prompt diagnosis and effective treatment plans to aid in recovery.

During the 2025 spring semester, the Bastrop ISD SHAC subcommittee, TBI Curriculum & Instruction, led by AES counselor Jennifer Blum, developed curriculum for PK-12 on age-appropriate safety and wellness lessons to help students make good choices to prevent head injuries, as well as providing older students with information on recognizing early signs of TBI in children to know when they should seek help for a peer, or a younger child they are supervising. These lessons will be taught during the normal health instructional time designated for each grade band in the 2025-26 school year. This curriculum was also provided to fellow Toyota Way Forward grant recipients at the children's hospitals in Philadelphia, PA and Detroit, MI, to share with their local schools.

In 2025-26, the Bastrop ISD SHAC subcommittee, TBI Community Awareness, will attend events throughout Bastrop county to provide families with information and resources to assist in

the prevention, and prompt treatment, of brain injuries in children. We look forward to our continued partnership with Lost Pines Toyota and Ascension Catholic Church, and are grateful for the opportunity to participate in truly meaningful work that serves our students and families.
