<b>Basic Information:</b>
The move from eSchool to PowerSchool has allowed us to assess all our internal systems and data management tools. We are currently utilizing multiple systems to house our data. We have had difficulty being able to easily pull the data and run reports. The system we have attempted to use for the last few years has not been customizable to meet our needs. We would like to consolidate our current systems and purchase EduCLIMBER.
<b>Background/Historical Context:</b>
We currently use Hoonuit (Unified Insights), Embrace MTSS, and Performance Matters as tools to help us track and monitor our data. Historically, We have encountered many issues with data being accurate and easily accessible.  As we transition to PowerSchool from eSchool we have identified a need to strengthen our discipline data system. eSchool has not been user-friendly and has required our teams to sift through layers to get to what they really need. PowerSchool does not have a discipline tracking system that will yield the results we need. As we begin looking into discipline systems, we realize that many of our systems are not aligned. Additionally, we use Performance Matters for tracking assessments. EduCLIMBER has a component called DNA that manages assessments.  We participated in demos from 4 companies that have data warehouse solutions: Panorama, Decision Ed, Abre, and Educlimber. We are already familiar with Hoonuit and Embrace as they are our current systems. After a deep dive into each system, we believe EduCLIMBER would best meet the needs of the district. The purchase of EduCLIMBER and the DnA module would allow us to eliminate MTSS Embrace, Hoonuit, and Performance Matters.  Here is the current yearly cost breakdown vs anticipated cost: Hoonuit \$31,944 Performance Matters: \$19,760 MTSS Embrace: \$5,600 Total: \$57,304/yr Total current system cost for three years: \$171,912
