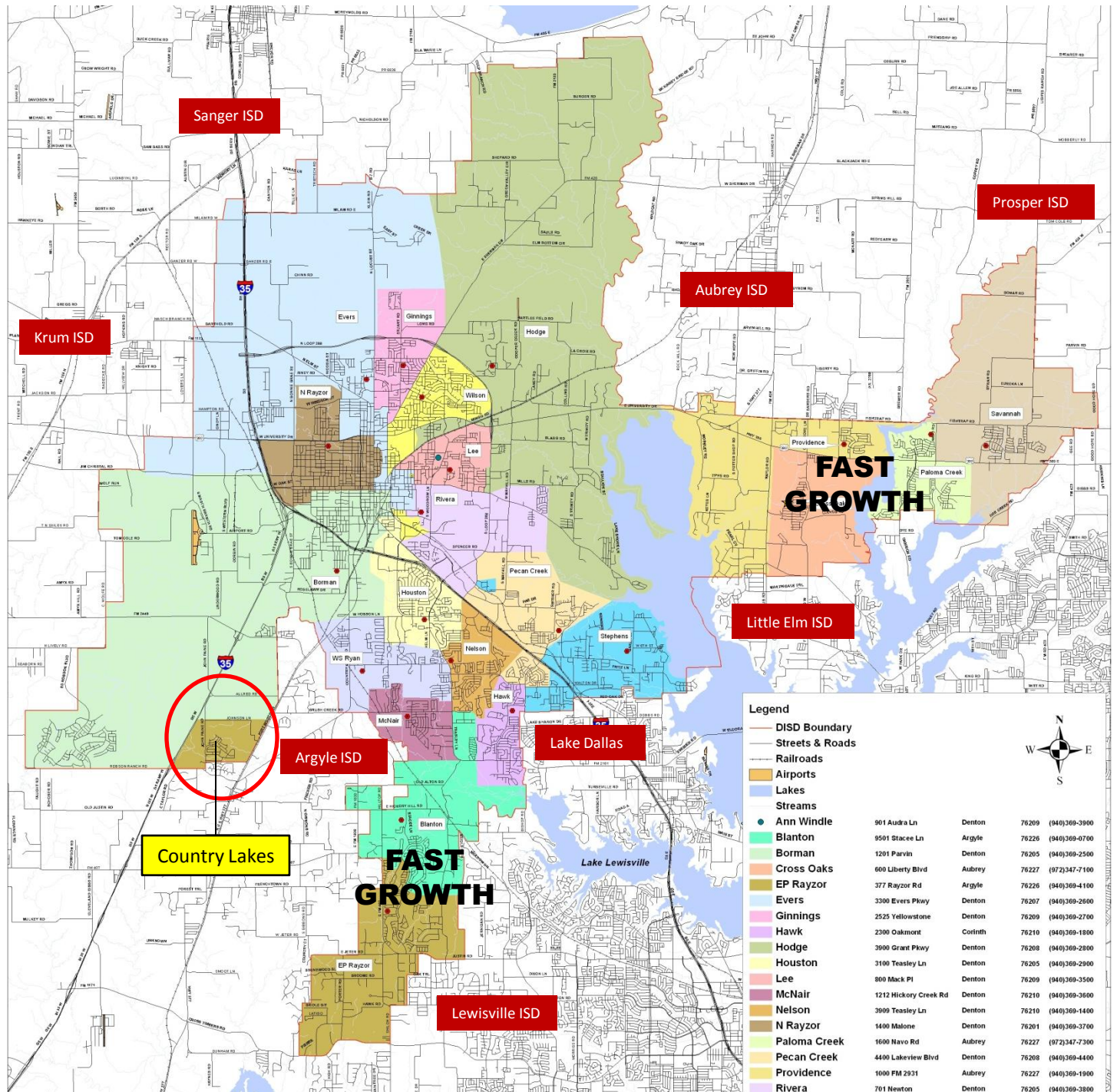

Why are we here?????

Why is Denton ISD re-zoning at this time??????

- Share & gather information
- E.P. Rayzor Elementary School is currently over functional student capacity
- Denton ISD elementary schools are designed and built to accommodate 740 students
- Service student growth in the southern sector of Denton ISD
- Balance student population to campus capacities at E.P. Rayzor & WS Ryan
- Economy has postponed the eventual construction of elementary school in Country Lakes
- State has reduced maintenance & operation funding to school districts

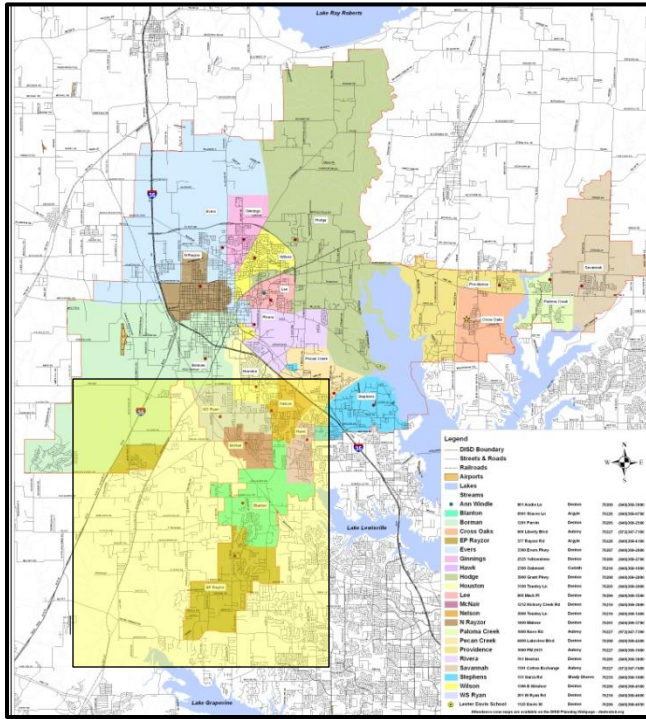
- E.P. Rayzor is currently over the functional capacity of 740 students
- W.S. Ryan has capacity over the next several years to absorb more students
- Blanton Elementary is experiencing growth and does not have capacity to absorb more students
- Mc Nair Elementary does have capacity but must be able to absorb overflow of Blanton Elementary



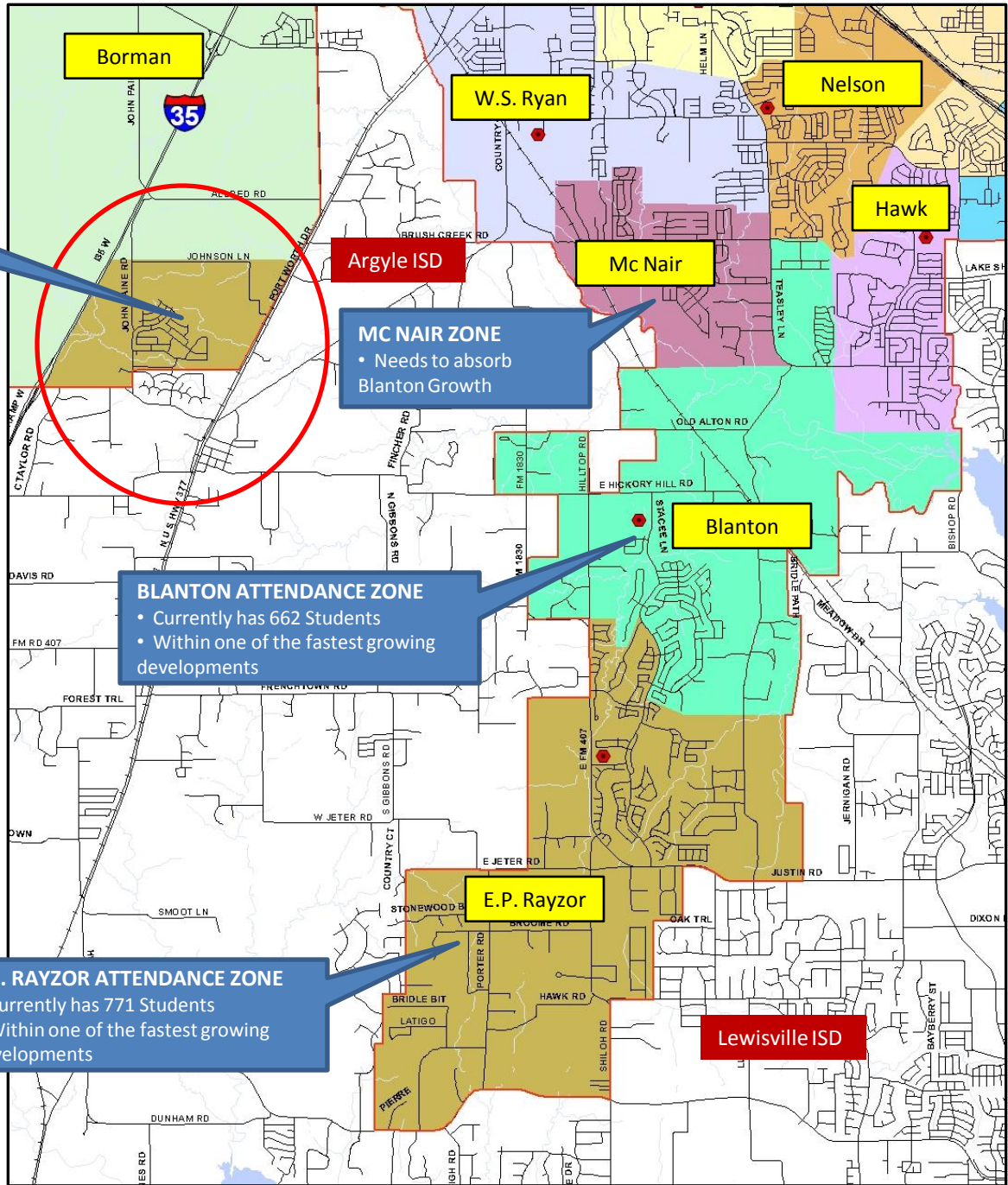
E.P. Rayzor Elementary to W.S. Ryan Elementary

- Future Elementary School Site within development

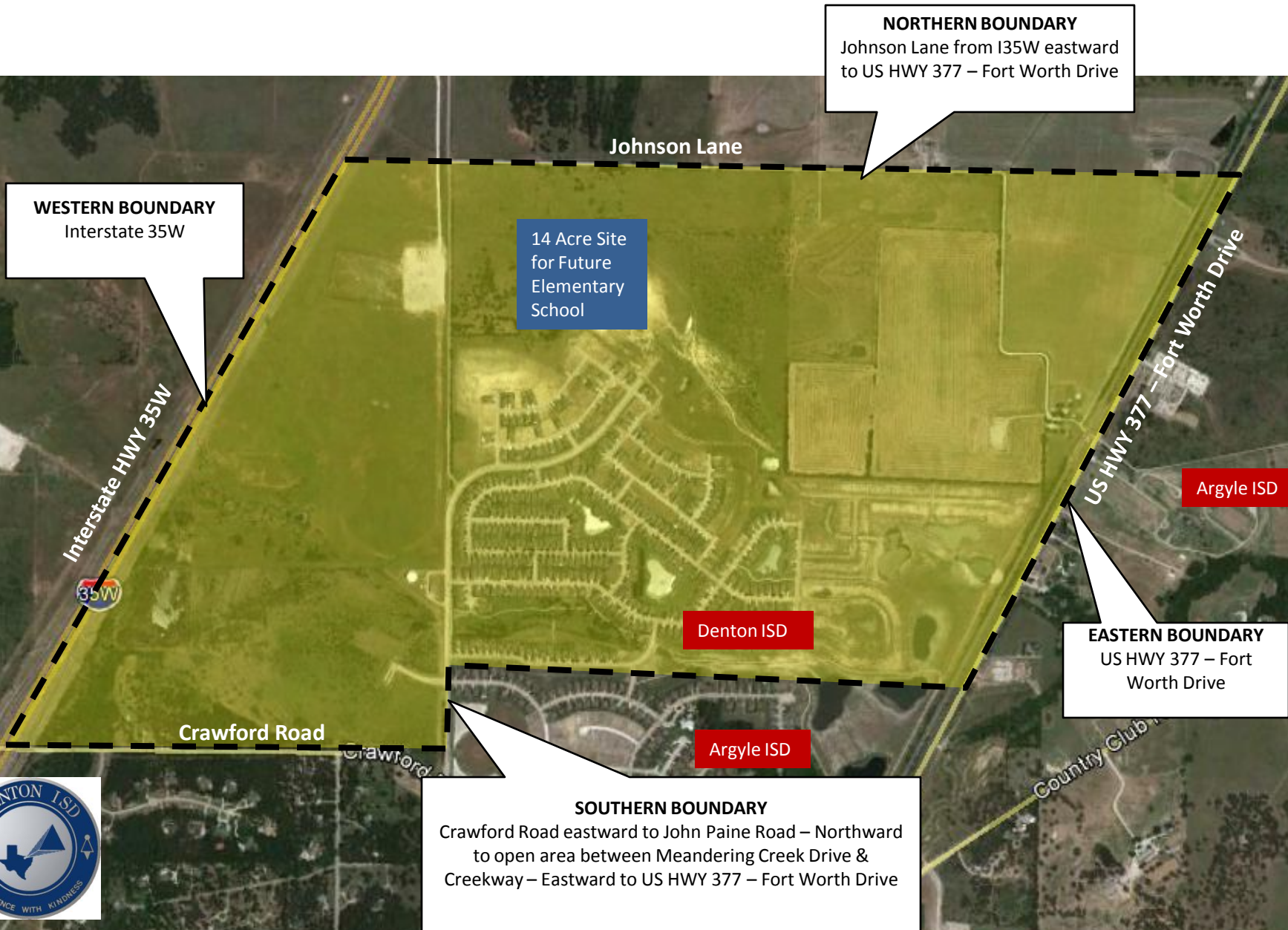


2011-12 ELEMENTARY SCHOOL ZONES

What happens next?

- Provide Board of Trustees with questions & comments from both attendance meetings
- Workshop Proposed Re-zoning Plan at Tuesday, December 13, 2011 Board Meeting
(Meeting will be held at Central Services Building – 1307 N. Locust Street – Denton, Tx 76201 : Starts at 6 p.m.)
- The public will have an opportunity to speak
(Must fill out card prior to speaking)
- The Board may decide to approve plan as presented or have further discussion
- If further discussion is needed, approval could happen at January 2012 Board Meetings



Samples of Questions Asked

- Will current students be given a choice to stay?
- How many students will actually move from E.P. Rayzor to W.S. Ryan?
- When will Country Lakes community get a school?
- How often does rezoning occur?
- Why is it important to rezone a small group of 90 students for a “band-aid” fix?
- What guarantee do we have that our children will not be assigned to another school in a few years?
- Why not send students to Blanton Elementary (Denton ISD) or Hilltop Elementary in Argyle ISD?
- Why not send them to Mc Nair Elementary?
- Why not just install portables?
- What about programs - if currently in Gifted & Talented or Dyslexia will students need to re-qualify?
- Will there be bus service?
- When will you rezone Middle School Zones? Currently, Country Lakes is zoned Harpool & DHS – Why?



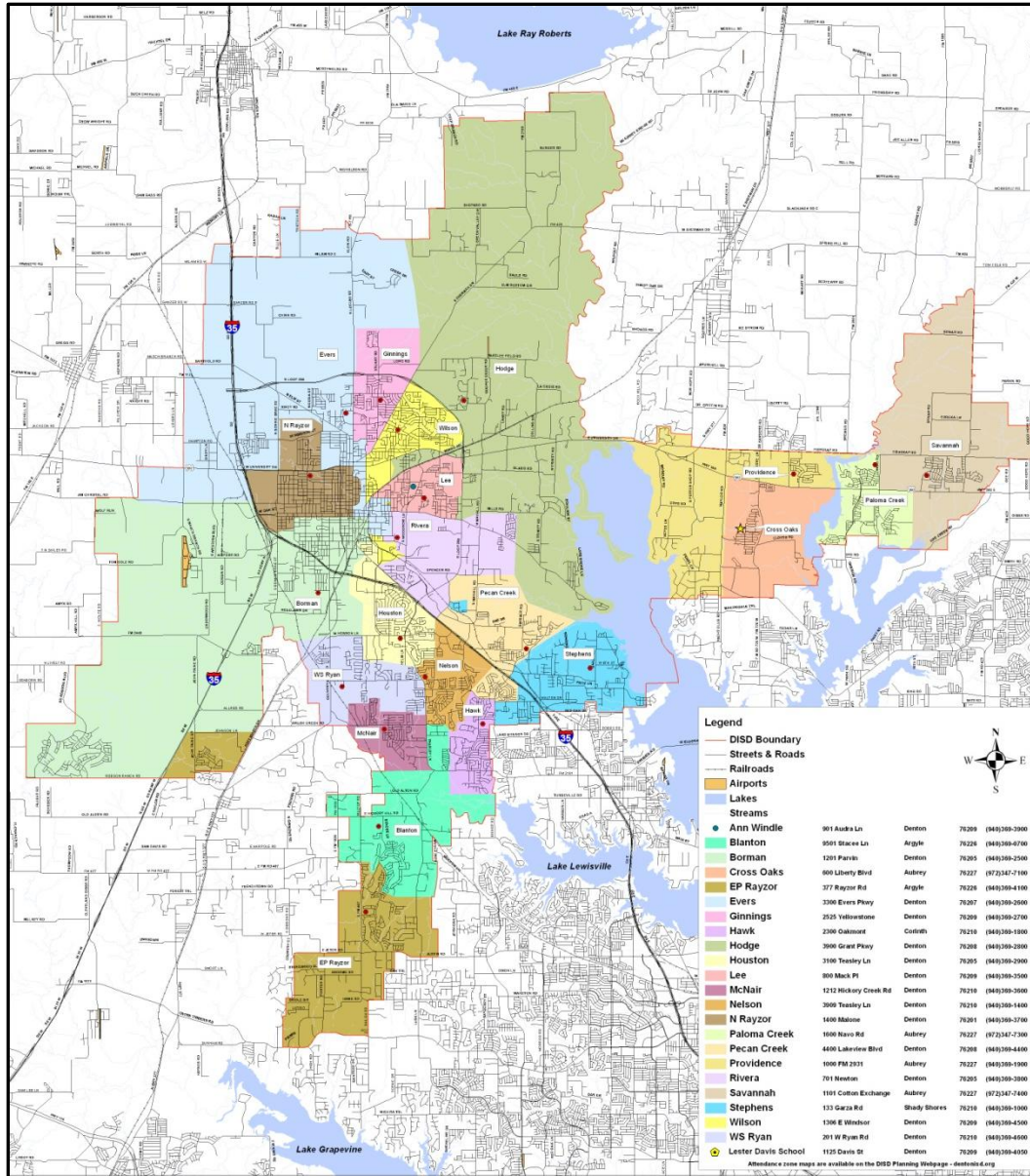

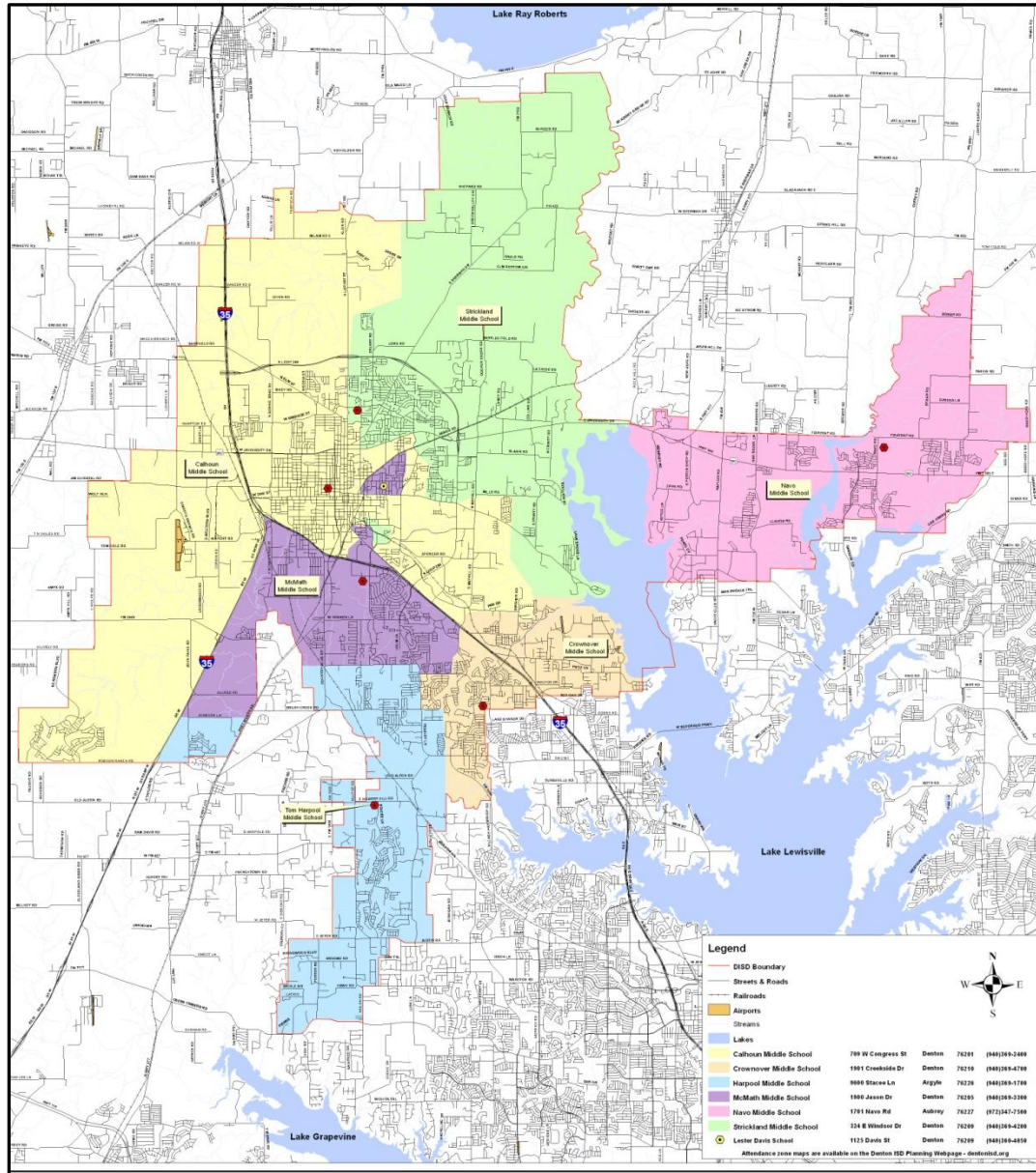
