Earl Holloway has offered to purchase 2721 Casey's Trail, McKinney, Collin County, Texas (BEING LOT 31, WINDMILL ESTATES ADDITION, aka 2721 CASEY'S TRAIL, COLLIN COUNTY, TEXAS, AS RECORDED AT INSTRUMENT 20060324000384060 OF THE COLLIN COUNTY DEED RECORDS) for \$7,200.00.

This property was sold at a Sheriff's Sale on July 3, 2012 pursuant to delinquent tax collection suit number 366-00433-2010. There were no bidders and the property was struck off to the Collin County Community College District for itself and on behalf of the other taxing jurisdictions.

The property's most recent value according to the Appraisal District is \$20,000.00. The property was struck off for the total judgment amount, \$32,352.70, which includes taxes, penalties and interest, costs of court, and costs of sale.
