Agenda Item Title: Approve the renewal of Amplify mClass Screener and Comprehension Assessment

Description: In 2020, TEA updated list of approved screeners, therefore, a committee reviewed options and chose Amplify mClass. We would like to continue using Amplify for the upcoming school year, 2021-2022. Amplify, mCLASS® Texas Edition, a publisher of next-generation curriculum and assessment programs. Texas Education Agency (TEA)-approved alternative Reading Diagnostic Tool for Kindergarten and as one of the options for grades 1–2, as legislated by HB3. Diagnostic tools, Universal Screeners for K-5th Grade (BOY, MOY, EOY), Dyslexia Screeners (Kinder, 1st Grade), teacher smallgroup lessons, and interventionist lessons for Special Education and Reading Teachers are all held in this platform. The state is providing the screener for free, so this purchase includes the screener for grades 3-5 and the comprehension assessment (TRC) for grades K-5. The comprehension assessment measures reading comprehension, which helps determine student reading levels, and provides insight into how each student finds meaning in text.

Historical Data: Amplify mClass was purchased last August 2020 to replace I-Station. I-Station was used from 2015 through 2020 as the TEA approved screener. I-Station is no longer on the list of TEA approved screeners.

Recommendation: Approve the license renewal of Amplify mClass Screener

2. License.
