NOTICE OF PROPOSED PROPERTY TAX INCREASE FOR PANA COMMUNITY **UNIT SCHOOL DISTRICT NO. 8**

A public hearing to approve a proposed property tax levy increase for Pana Community Unit School District No. 8 for Fiscal Year 2025 will be held on December 18, 2023 at 6:15 p.m. at the Unit Office Board Room, 14 East Main Street, Pana, Illinois.

The corporate and special purpose property taxes extended or abated for fiscal year 2023-2024 were \$5,973,551.

The proposed corporate and special purpose property taxes to be levied for fiscal year 2024-2025 are \$6,556,850 represents a 10.04% increase over the previous year.

The property taxes extended for debt service and public building commission leases for fiscal year 2023-2024 were \$838,829.

The estimated property taxes to be levied for debt service and public building commission leases for fiscal year 2024-2025 are \$861,225. This represents a 2.66% increase from the previous year.

The total property taxes extended or abated for fiscal year 2023-2024 were \$6,812,380.

The estimated total property taxes to be levied for fiscal year 2024-2025 are \$7,418,075. This represents a 9.13% increase from the previous year.
