District-Wide Housing Furniture Replacement (Informational Item)

NSBSD Policy Manual:

Board Policy 3300 Expenditures/Expending Authority: The Superintendent or designee may purchase supplies, materials, and equipment in accordance with the law. The Superintendent or designee shall not authorize any proposed expenditure that exceeds the major budget classification allowance against the expenditure is the proper charge unless an amount sufficient to cover the purchase is available in the budget for transfer.

Board Policy 3310, Purchasing Procedures: The School Board desires to ensure the maximum value is received for money spent by the district and that records are kept in accordance with the law. The Superintendent or designee may issue and sign purchase orders.

Board Policy 3311, Bids: The district shall purchase equipment, supplies and services on competitive bidding basis when required by law and whenever it appears to be in the best interest of the district to do so. Prior to any purchase, the district should review the federal funding award or grant to determine if it requires compliance with OMB's procurement procedures.

6.0 Staff Support & Professional Development: Build and sustain a thriving workforce aligned with the mission of the district.

7.0 Financial & Operational Stewardship: Standardize high functioning, efficient, student-focused operations.

Issue Summary:

As part of a 2-year administrative focus on standardizing district operations, the M&O department sought bids for housing furniture replacement district wide to ensure equity and consistency for recruited staff. This is in line with a strategic focus on retention of quality staff and predictable budget forecasting for supply and replacement of furniture.

A formal posting on Alaska Daily News ad section was posted November 26, 2024 – December 23, 2024. We received one (1) formal bid. Due to this, the request for bids was extended until February 3, 2024. We intend to award the bid to Bailey's Furniture. The bid received from Bailey's furniture meets all required specifications and offers favorable terms for the project.







Limited Warranties are non-transferable. The following Limited Warranties are given to the original retailer of the following Products:

Frames Used In Upholstered Products (Fabric and Leather) 10 Year Limited Warranty

A Limited Warranty applies to all steel frames used in upholstered sofas, love seats, chairs, ottomans, and sectionals. Designs 4 Life Pte Ltd ("D4L"), warrants these components to you, to be free from material manufacturing defects. D4L will provide, within ten years from the date of purchase, either a replacement or a credit for the defective Metal Frame at no charge to the original retailer. The frame warranty covers the structural integrity of internal steel frame only, it does not cover tamishing or oxidization of the frame. This Warrantee covers a maximum of our FOB cost. D4I will not be responsible for labor, packing or any shipping and transportation costs.

2 Year Limited Warranty

The metal no sag spring seat systems, and, where applicable, back springs, and are secured by heavy gauge tie wires clipped at all intersections. D4L, warrants these systems to you, the original retailer, for two years from the date of purchase, against spring breakage caused by metal fatigue or spring clips pulling loose from the frame. D4L will provide, within two years from the date of purchase, either a credit, repair or replace the defective parts at no charge to the original retailer. The spring warranty covers replacement parts only, D4I will not be responsible for labor, packing or any shipping and transportation costs.

2 Year I imited Warranty

All seat cushion cores will soften with normal use and will conform to the shape of the user. This shall be considered normal wear, and shall not be considered a loss of resiliency or a material manufacturing defect.

With respect to a cushion core in a seat cushion which is attached to the product (an "Attached Cushion"), D4L, within 2 years from the date of purchase, will either credit or replace, for the original retailer only, a sofa which has material manufacturing defects. This Warrantee covers a maximum of our FOB cost. D4I will not be responsible for labor, packing or any shipping and transportation costs.

1 Year Limited Warranty

D4L warrants to you, the original retailer, for a period of one year from the date of purchase, all fabrics against seam slippage, fraying, and dye transfers. This warranty does not cover tears, flattening of nap, pilling, fading, or shrinking and is not valid when heavy soiling or abuse is evident.

This warranty does not cover fabrics specified by the customer, it also does not cover protective finishes, crushing or marking of velvets, velvet types, since by their very nature, these fabrics are of soft texture and will crush, shade and mark more readily than most fabrics; these characteristics are in no way to be considered a defect. D4L will provide, within one year from the date of purchase, replacement for the defective parts at no charge to the original retailer. This Warrantee covers a maximum of our FOB cost. D4l will not be responsible for labor, packing or any shipping and transportation costs.

2 Year Limited Warranty

D4L warrants to you, the original retailer, for a period of one year from the date of purchase, all leather to be free from defects in materials and workmanship, seam slippage, cracking, and dye transfers.

Leather is a natural product, and, as such, each hide will reflect its own individuality. Some variations of shade and tone are to be expected as are the nicks, scratches, and wrinkles that only occur in genuine leather; these characteristics are in no way to be considered a defect. D4L will provide, within one year from the date of purchase, either a credit or replacement for the defective parts at no charge to the original retailer.

SHEESHAM WOOD INFORMATION

Sheesham furniture is very popular in Indian subcontinent. But homeowners are often ignorant about what is Sheesham wood. In order to make an informed decision before buying Sheesham furniture, it is important that you know about it. So this article covers the following aspects:

Sheesham wood is also known as Dalbergia Sisso, a deciduous tree, called Sheesham in the Indian subcontinent. It is grown across the length and breadth of the sub-Himalayan region, extending from Assam in the east to River Indus. These forests go all the way across Punjab, Uttar Pradesh, West Bengal and Assam. Here, it is known by various names, like Sheesham, Shishan, Shisham, Sissoo or Sisu.

<u>Sheesham tree:</u> It is the state tree of the Indian state of Punjab where this wood ranks No. 2 after teak in size of cultivation. It has various applications apart from supplying timber, such as being planted on roadsides and on tea plantations for shade and along canals.

This tree usually grows along riverbanks below an elevation of 900 meters but can go up to 1,300 m. It grows best in temperatures ranging from 10°C to 40°C. It can withstand an average yearly rainfall of a maximum of 2,000 mm and droughts not exceeding three to four months. Sheesham grows best in pure sand and gravel and rich soil of riverbanks and can also flourish in slightly salty soils.

Features: Sheesham wood ranges from being golden brown to a dark brown or chestnut color with darker streaks that give this wood a rich and lustrous appearance. The wood is sturdy and tough with a straight grain, though it could also be found to be interlocked. Its texture ranges from medium to coarse with a natural luster.

Benefits of Sheesham wood

- It has an innate resistance to decay and is popular for woodcarving and for engraving goods in India
- This wood neither warps nor splits, so it is highly used for making cabinets and other furniture.
- Highly durable wood and offers great resistance to dry-wood termites.
- · Due to its toughness cutting and sawing could be a big challenge, but it is great for turnery.
- It shines under polishing and has a smooth finish.
- The grain is so well defined that each piece of Sheesham furniture often has its own unique color.

 This wood accepts hand waxing which gives it a smooth surface.
- This wood has applications in marine and aircraft plywood, as charcoal for cooking and heating food, making musical instruments, ornamental turnery, sporting goods and for carving and engraving.
- It is also used for making doors and windows, while its root wood is often used for making tobacco pipes.
- Sheesham wood accepts a good polish and gives a smooth finish and luster.







Characteristics of Sheesham Wood

Sheesham wood or Indian Rosewood, is found largely in India, but also in Pakistan and Nepal. Sheesham trees have a life of 22 years during which period they attain a height of 30 meters. Their diameter is a maximum of 1.5 meters, and they are known to produce heavy and dense wood.

The strength of the wood of these trees is excellent and unparalleled, rendering it the obvious choice for high quality wooden furniture. Once polished, the wood shows up a smooth and extremely attractive surface. Its grain makes each piece of furniture absolutely unique and highly sought-after.

This warranty supersedes and replaces all implied warranties of merchantability and for particular purpose. No representative, employee, agent of Porter Designs, or any other person is authorized to assume for Porter Designs any additional liability or responsibility in connection with Porter Designs' merchandise except as described above. WHAT IS COVERED:

Deluxe Home Of USA Inc/Delandis warrants your Mattress, for a period of ten (10) years from the date of purchase against defects in workmanship and materials. During this Limited Warranty period, if the product is deemed to be defective, our responsibility for the defective product is limited to repair or replacement as stated below. All transportation costs are the responsibility of the purchaser during the entire Limited Warranty period. Your mattress will be replaced or repaired, at our option, should it be found defective because of faulty workmanship or structural defects subject to specific limitations contained herein.

WHAT IS NOT COVERED: It is understood that this does not include normal increase of softness in the foam which can occur during normal breaking in, or in the case of visco-elastic memory foam, a lessening of the gradual recovery aspect of the foam, of which such lessening, should it occur, does not reduce the continual pressure reducing and pressure relief properties of the mattress. Substitution or use of improper foundations, platforms or other bases upon which the mattress is placed, may result in damage to the product. Should an improper base be utilized by the consumer, causing the product to default, the Warranty may be voided. MATTRESS UNWRAPPING

Step 1: After removing the compressed mattress from the box place it on the bed frame where your mattress will ultimately be so you don't have to move it after it decompresses.

Step 2: Carefully remove the outer plastic cover with scissors. Exercise care and remove the plastic cover by hand.

Step 3: Gently pull the compressed product to unroll it. At this point, you may need to flip it over so the underside of the mattress is on the bed frame.

Step 4: Carefully trim the inner plastic cover with scissors to start the mattress decompression. Gently pull away the inner plastic cover and discard.

Tips

- Please allow 24 to 72 hours for your Mattress to regain its full shape.
- We DO NOT recommend use of an electric blanket or pad with this mattress.
- In cold temperature, at delivery, your mattress may take a bit longer to return to full sized from its compressed state.

MATTRESS CARE TIPS

Mattress Cleaning

DO NOT REMOVE OR WASH COVER. Spot Clean only. To spot clean, Vacuum your mattress, sprinkle some baking soda on it. Use a scrub brush to gently rub the powder into the mattress and leave it for 10 minutes or so. Vacuum the excess powder.

- · Do not wash.
- Do not use bleach.
- Do not machine dry.
- · Do not iron.
- · Do not dry clean.

Airing Out Your Mattress

Foam mattresses typically have a mild residual scent distinct to the product when new. This is sometimes heightened when delivered during cold weather. It will quickly dissipate as the mattress is used daily, allowing the open cells to expel the "processing" air and take in new air.
