With an extended response proposal, evaluations and awards are granted to additional vendors on a rolling basis throughout the solicitation period. This period remains open year-round until the final renewal option expires. Responses are evaluated as they are received, and vendors are notified of the district's decision accordingly. Newly approved vendors will be included in the list of awarded vendors submitted to the Board during each annual renewal. This means that while vendors may be added throughout the year under the extended response process, their names and award details will be formally reported as part of the renewal documentation submitted for Board review and approval each year.

The district issued a Competitive Sealed Proposal (CSP) #25-009, for *Fresh Baked Goods – Extended Response* to ensure quality and reliable service for our bakery needs for district-sponsored meetings and events. Nine (9) responses were received and opened by the purchasing department on Friday, April 25, 2025.

An evaluation committee comprised of representatives from various departments was convened to review and assess the proposals. Each response was evaluated based on the criteria outlined in the solicitation. Committee members scored each category individually, and the scores were compiled to determine an overall ranking for each vendor. Based on the evaluation results, the committee recommends awarding the following vendors:
