President Leigh called the meeting to order at 6:00 p.m. on February 24, 2025, at 1205 S. 70th Street, West Allis.

6. James E. Dottke Project-Based Learning High School Student Showcase

James E. Dottke Project-Based Learning High School Principal Goelz briefly reviewed the District's Theory of Action and how it connects to the learning that the students will be sharing. Principal Goelz also recognized math teacher Ms. Brunette and social studies teacher Mr. Dedering. Freshman Nikolas Rodriguez, a student of Ms. Brunette, detailed how he incorporated algebra while creating a steampunk-themed clock. Freshmen Shane Jafuta and Lorenzo Allen, who are both students of Mr. Dedering, presented their project entitled "The History of U.S. Aviation", which included a detailed poster with hand drawn plane replicas, as well as handmade model plan. President Leigh and Dr. Robinson thanked parents, students, and staff for attending.

7. Superintendent's Report

7.1 Legislative Update:

Governor Evers introduces state budget:

Governor Evers introduced his fourth state budget to the Wisconsin State Legislature, proposing over \$3.15 billion in new K-12 education investments. The operating budget is nearly \$119 billion over the biennium, an over \$10 billion increase compared to the current fiscal year. The budget focuses on equitable funding, mental health support, literacy improvement, and reducing financial burdens on families. Key initiatives include general equalization aid, targeted categorical aids, and sparsity aid. The budget also includes \$300 million for expanding comprehensive mental health services, \$84.6 million for improving early literacy, and \$154.8 million for free school meals for all students.

Money allocation for early literacy initiatives will likely revert to the surplus:

Wisconsin's state Rep. Joel Kitchens is drafting a bill to release \$50 million in early literacy funding from the Joint Finance Committee (JFC) to avoid it reverting to the surplus when the deadline passes on June 30. The Wisconsin Supreme Court agreed to hear a case to review the Governor's partial veto of the appropriation bill and determine whether the Joint Finance Committee is improperly holding onto the money. However, the court has yet to schedule oral arguments in the case, and with the upcoming Supreme Court election, it appears less likely the court will reach a decision before the deadline for the lapse of funds. The \$50 million was allocated to fund the mandated changes to how Wisconsin children learn to read in 2023. The money is tied up as the Legislature awaits oral arguments and a decision by the state Supreme Court over whether the governor had the authority to strike funding for school boards and charter school compliance from the law.

7.3 Other Updates & Information Items:

Community Visits and Meetings:

Dr. Robinson gave an update on his recent meetings and community visits since February 10, 2025, which included the following meetings: Monthly City/ Schools, West Allis Rotary Club, and State Representative Tenorio. Dr. Robinson also noted the following school visits: Instructional Rounds at Hale, West Milwaukee, Central, Irving, and Dottke; Superintendent Connections Visits shadowing staff and providing side-by-side coaching; and visited Hoover, Wilson, Irving, and Franklin Elementary Schools during District-wide Professional Development Days.

"The Voice"- Student Advisory Committee:

Dr. Robinson introduced Student Advisory Committee "The Voice" representative John Gruichich, a senior at Nathan Hale. Mr. Gruichich is a member of the core team for Renaissance (student leadership team), cross country and track teams, National Honor Society, and Rotary. Additionally, Mr. Gruichich is enrolled in multiple AP classes. Mr. Gruichich stated that for the first time in twenty years, Hale's wrestling team took first place at sectionals and noted Kya Krueger is the team's first-ever female wrestling state qualifier. Additionally, four members of the varsity wrestling team, Jay Krueger, Tristan North, Thomas Medley, and Brody Sardina, have each achieved over 100 career wins this season. Varsity boys basketball player Wilson Scherer recently joined the 1,000 points club and is the fifth person in the history of the school ever to do so. Rehearsals for Les Miserables are underway and performances will run April 24-27, 2025. Lastly, track season starts March 10, 2025.

Detachment:

At the close of business on January 31, 2025, there were three detachment petitions filed, and they are as follows:

- Petition 1 was filed on November 15, 2024- Includes 1 parcel and 2 signatures;
- Petition 2 was filed on January 27, 2025, at 9:00 AM- includes 134 parcels and 116 signatures;
- Petition 3 was filed on January 27, 2025, at 10:00 AM- includes 1 parcel and 1 signature.

- During the review of the petitions, it was determined that Petitions 1 and 3 met the statutory requirements and would be forwarded to the board for consideration.
- According to 117.12 (3), "During the month of February, each affected school board must give the petitioners an opportunity to meet with the board to present reasons for the proposed reorganization before adopting a resolution either granting or denying the detachment."
- Petitions 1 and 3 were heard during the WAWM Board meeting on 2/10/25, which included presentations from the petitioners and questions from the board. Tonight, the district will provide a specific response to Petitions 1 and 3.
- Upon further examination of Petition 2 we noticed it contained a parcel and signature of the petitioner from Petition 1.
- Upon further review by our legal counsel, and in consultation with the Wisconsin Department of Public Instruction Attorney, we have determined that Petition 2 filed on January 27, 2025, is void under Wis. Stat. 117.05(4)(b), as it contains territory proposed to be detached that is already pending in another proceeding.
- The rules prohibit multiple petitions from homeowners during the same review cycle.
- DPI has determined that once a petition has been deemed as "void" then it is unrevivable.

9.2.1 Employee Engagement & Culture – Keller

Committee Chair Keller reported that the Committee met on February 18, 2025. The Committee discussed the Substitute Program and agreed that once an additional Cabinet-level discussion takes place, the Committee will revisit the topic at its next meeting. The Committee reviewed the vacancy report, which is just a bit over 0.5%. The Committee also discussed the exit interview process and how to better correlate the data.

9.2.2 Financial Stability & Efficiency – Burns

Committee Chair Burns reported that the Committee met on February 17, 2025. The Committee reviewed the booklet and presentation for the 2023-24 Audit Workshop. The Committee discussed the compensation model and next steps, housing for All WHEDA Bid for the Longfellow property, Committed Fund Balance (\$3 million - Retiree Benefits, \$2.75 million - Comp Model, \$700,000 - Teacher Computer Refresh). The Committee also received a referendum update, which included financial services, the project manager position, and bids for construction management and owner's representative.

Committee Member Lee reported that the Committee met on February 17, 2025. The Committee discussed construction and project updates. A "Save the Date" for the Activity and Fitness Center (AFC) and groundbreaking, which will take place on Monday, April 7, 2025. The Committee has also continued work on the Athletic Strategic Plan, which included a date to review the plan with athletic directors, coaches, youth programs, etc. and determine a timeline for an upcoming Board Workshop. President Leigh requested that the Committee consider investigating opportunities for potentially adding flag football for girls.

12.1 AGR Data Review – Ruffolo

Keith Ruffolo, Coordinator of Elementary Education, led the Achievement Gap Reduction (AGR) Data Review Workshop. Mr. Ruffolo reviewed the AGR timeline, allocated funds, classes by school and grade, current steps, and FastBridge performance goal, which is to reduce the number of students in the high-risk category by 10% according to the FastBridge aReading & aMath assessments. Mr. Ruffolo reviewed fall through winter K-3 district data and provided immediate next steps for reading (personal reading plans) and math (professional learning around HMH Into Math). Long-term next steps include master schedule updates, teacher collaboration time, leadership capacity building, and a universal screening process. The Board will receive its next update in July 2025.

12.2 Financial Stability & Efficiency – Norris

Aaron Norris, Assistant Superintendent, led the Financial Stability & Efficiency Workshop, which detailed enrollment (actual students) and membership (resident students who live in District boundaries) trends and a combined presentation of the below agenda items:

- 12.2.1 Second Friday in January 2025 Pupil Count (6,618)
- **12.2.2 2025-26** Enrollment Projections (6,464)
- **12.2.3 2025-26 Estimated Revenue Limit Calculation** (3-year Average Membership of 7,418 x Per Pupil Allocation of \$11,763 = Total Revenue Limit Authority of \$87,258,973)
- 12.2.4 2025-26 Preliminary Budget Projections (2025-2026 is Year 1 in the State's biennial budget (2025-2027), which means the District's preliminary budget is in flux until State Budget Approval. Typically, the District will have some preliminary information by mid-April/early-May. State budget factors based on the Wisconsin Department of Public Instruction, Governor's Ask, WASB and WASDA, District's Ask were considered when determining the financial impact. Revenue and expense assumptions projected a [balanced] projected 2024-26 budget of \$8,873,090.)

Esteemed Senators and Representatives,

Attached is a resolution passed by our Board of Education, urging you to support a variety of critical measures in the 2025-2027 Biennial State Budget. This resolution includes advocacy for a 90% reimbursement for special education, an increase in the low-revenue ceiling to \$12,500 for the 2025-26 school year, a \$425 per pupil increase each year of the biennial to address spendable revenue, and other key financial supports designed to ensure equitable access to quality education for all students. These measures are vital for the sustainability and success of our district and the broader community.

One of our primary requests is an increase in the low-revenue ceiling to \$12,500 for the 2025-26 school year. This increase is essential for districts like ours, where financial constraints severely limit our ability to provide adequate resources for students. Currently, 72.9% of all school districts in Wisconsin receive funding below the state average revenue limit per student. Raising the ceiling would allow us to better meet the needs of our students and continue offering high-quality education. Moreover, the stark disparities between school districts in Wisconsin create an environment where some districts thrive, while others struggle to meet basic needs. The gap between "have" and "have-not" districts only widens without the necessary financial adjustments, further entrenching inequities in education across the state.

In addition, we strongly urge you to address the issue of spendable revenue by implementing a \$425 per pupil increase each year of the biennial. This increase is essential for ensuring that all districts can provide the necessary services and opportunities to their students, regardless of local wealth. The current funding levels have not kept pace with the growing demands of our schools, and this increase would help ensure that each student receives the educational experience they deserve.

Like many districts across the state, we have repeatedly had to turn to referendums to secure the resources we need. This burden disproportionately affects communities with lower-income constituents. It is imperative that we have fair, equitable reimbursement for students with disabilities and that we secure the financial flexibility necessary to sustain our educational programs.

We are grateful for your ongoing commitment to public education, and we encourage a collaborative approach to addressing these critical issues. Please feel free to reach out if you'd like to discuss any of these points further.

Thank you for your consideration of our resolution as we continue our work to advocate for all of Wisconsin's children.

West Allis-West Milwaukee Board of Education 2025 Legislative Advocacy Resolution

Whereas, The Wisconsin Department of Administration (DOA) estimates the state of Wisconsin will have a gross general fund balance of approximately \$4.0 billion at the end of the current fiscal year and this figure does not include the \$1.9 billion plus balance in the state's budget stabilization ("rainy day") fund, which continues to be at a record-high level; and

Whereas, The school property tax levy as a percentage of personal income (tax burden) is at 1.5%, a record low level, down from the peak of 2.81% in 1993; and

Whereas, According to the Wisconsin Public Policy Forum, the state's ranking for spending on K-12 schools totaled 3.8% of personal income in 2022, which was down from 3.9% in 2021 and 5.2% in 2000; and

Whereas, The state's ranking in special education spending in 2022 was 31st, down from 24th-highest in 2021 and 8th-highest in 2000, representing a major shift in the single largest area of state and local spending; and

Whereas, Approximately 1,293 students of the 6,654 total student population (19.4%) in the West Allis-West Milwaukee School District is identified in need of Special Education services; and

Whereas, School districts in high-poverty areas are hit the hardest by special education costs and state government has reimbursed districts for less than one-third of their total special education costs over the last decade; and

Whereas, Students receiving Special Education services in the West Allis-West Milwaukee School District should not be treated differently than students who attend Private School Choice Programs in relation to the reimbursement for services received; and

Whereas, The West Allis-West Milwaukee School District needs adequate resources to support students with disabilities to reduce the amount currently transferred from the general funds to cover the gap between mandated special education costs and state funding; and

Whereas, Increases in special education funding provide more predictable, stable funding that supports all students due to less of a transfer from the district's general fund; and

Whereas, Increasing the low-revenue ceiling will provide a more sustainable and fair distribution of state funds, addressing disparities in per-pupil funding across districts; and

Whereas, nearly 73% of all school districts in Wisconsin receive funding below the state average Revenue per Member; and

Whereas, Spendable dollars for schools are crucial for ensuring equitable access to quality education and enabling districts to meet the diverse needs of their students.

Let It Be Resolved that the West Allis-West Milwaukee School District Board of Education strongly endorses and advocates for the Wisconsin State Legislature to:

- Increase Special Education funding to 90%,
- Raise the low-revenue ceiling to \$12,500, and
- Provide all public school districts with spendable dollars in the form of \$425 per student in the first year of the 2025-26 State Biennial Budget.

This resolution reflects the Board's commitment to securing equitable and sustainable funding to support the needs of all students and ensure the continued success of public education in Wisconsin.
