6B. Texas Education Agency Requirement to Develop and Implement Campus Turnaround Plans

Presenter: Dr. Terri Osborne

Dr. Osborne presented a detailed overview of the turnaround plan requirements for Manor, Palo Alto, and Eastern Hills Middle Schools. She explained that each campus triggered the state mandate after multiple years of unacceptable ratings, necessitating a three-year comprehensive plan. The presentation described the Effective Schools Framework and the

role of district and campus collaboration in addressing persistent underperformance. Trustees asked questions about accountability cut scores, community involvement, and the differences between targeted improvement and turnaround plans. Discussion also included restructuring options such as ACE programs or 1882 partnerships, and the potential long-term implications for district governance if improvement benchmarks are not met.

Dr. Osborne provided a comprehensive review of the district's student success goals under the system scorecard. She highlighted the ongoing tracking of student performance measures, including academic growth, graduation readiness, and college/career pathways. Trustees emphasized the importance of consistent monitoring and accountability across campuses. They also asked for clearer timelines on performance reporting to ensure progress can be evaluated regularly. Discussion reflected strong board interest in aligning student success metrics with district priorities and community expectations.
