5. Board Report

• Mrs. Salas stated last week she had the honor of attending The Capitol with the Superintendent Student Advisory Council and Legislative Committee students. She thought it was great that Dr. Waldrip saw a student there that is now an intern at the

Capitol. This student was previously on the Superintendent Student Advisory Council and attended Lone Star High School. The intern took the time to speak with the students.

- Mr. Ponangi spoke about principal Christy Garza giving the Campus Spotlight
 presentation at the February Board Meeting. He then visited Christie Elementary on
 February 24th and was involved in the Idea Lab. He said the students were doing amazing
 work and he enjoyed watching them put things together and their ideas and executing. He
 felt they are future leaders and engineers in that classroom. He thanked Mrs. Garza for
 the experience. The T & L Sub Committee visited Smith Elementary, and he will let Mrs.
 Elad speak more about that visit.
- Mrs. Elad spoke regarding how Ms. Davis, Mr. Ponangi, and she visited Smith Elementary as the T&L subcommittee. She thanked Dr. Fiori for setting up this visit for them. The subcommittee has been working on grading this year and will have an update at the April Regular Board Meeting. They are now pivoting to how we teach reading in the district. At Smith they visited two different grades and classrooms. She was amazed how the teachers manage this including the books and the one-on-one time. She thanked Dr. Fiori.
- Mr. Lowe visited the Capitol a couple weeks ago and talked to legislators on the district's behalf. He wanted to give a shout out to Mrs. DeWolfe as he was very impressed with the way she talked up the district. He said so many people want to vote for things that are controversial or things the Board could be divided on. district. Staley is also smaller which gives these students more experiences that larger schools. He feels closing Staley would also be closing a Legacy.

- Kristina Earhart has two sons and the youngest is an 8th grader attending Staley Middle School. She has lived in the Staley zone for 25 years and disappointed with the citizens for the last election. Our kids need the Staley Community. Please find a way to build a new Staley.
- Clare Nixon has been a member of the Frisco Community for 20 years and loves Frisco ISD. Especially the Rogers/Staley/Memorial path. These parents choose this neighborhood. Staley is unique with amazing kids. Clare is now a Special Education teacher at Memorial High School. She feels teachers at Staley choose to be there. If the district retires Staley those students will no longer attend a title I campus. Please keep Staley or put in a plan to get Staley students to afterschool activities.
- Christy Williams has 4 kids and one just graduated from Memoria High School last year. In her neighborhood in the morning when it is still dark, she sees students walking t practice whether it be Football, Basketball, or Soccer. The Staley community loves and supports the kids well. She is worried about the students losing the title I status and supports. She thanked the board for the information, questions, and responses about Staley. She wants to also make sure the needs are met for the Staley students at the school they will attend if Staley closes.
