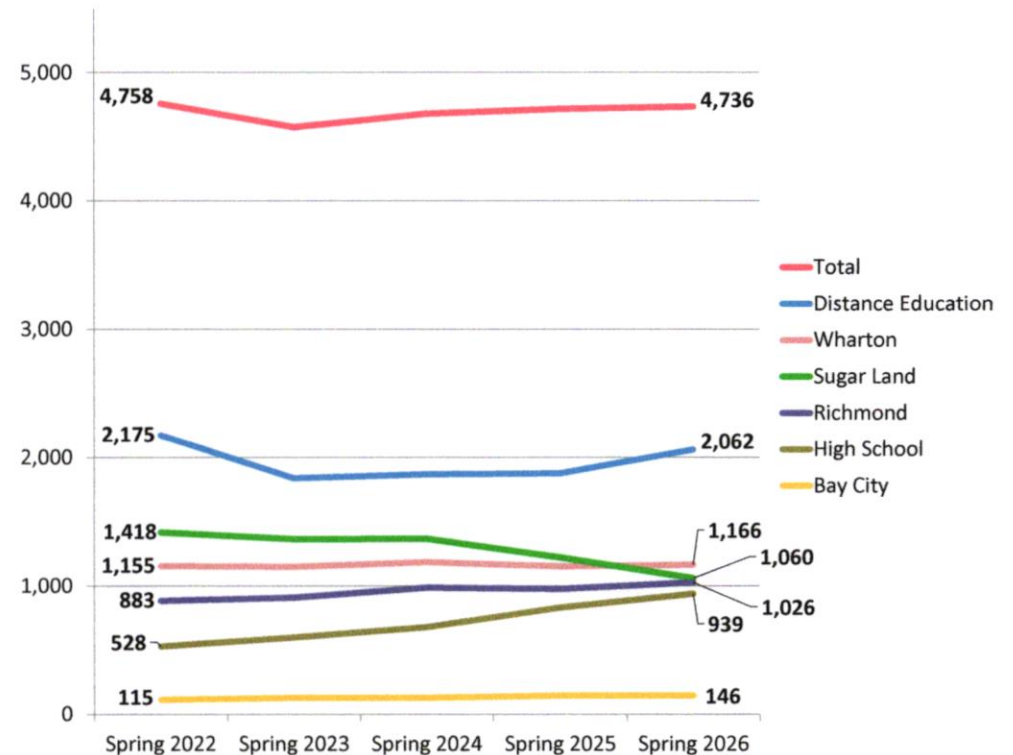


Spring Enrollment

First-day enrollment for **Spring 2026 is holding steady** compared to Spring 2025, reflecting stability in our overall student population.

Notably, we are seeing **positive growth in Distance Education and Dual Credit enrollment**, demonstrating continued demand for flexible learning options and strong partnerships with area schools.

By campus, **Sugar Land experienced a decline for the second year in a row**, while all other campus populations remain stable.





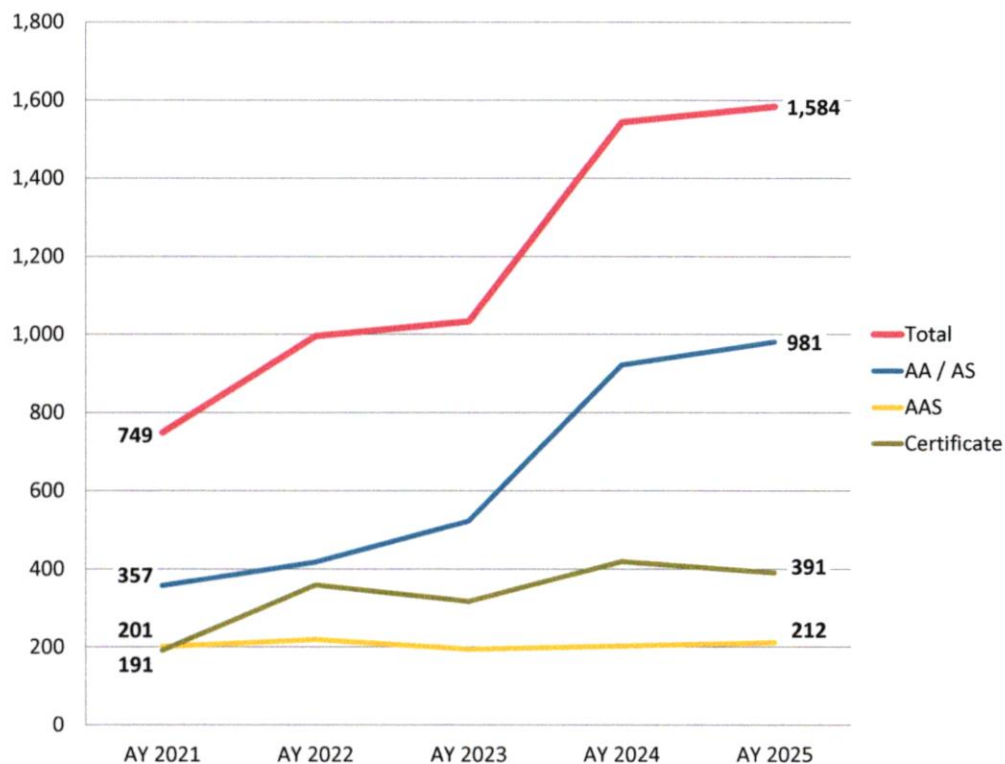
Degrees Awarded

In November 2025, WCJC submitted our official completion data to the Texas Higher Education Coordinating Board for Academic Year 2025.

In AY 2025, WCJC awarded a total of **1,584 degrees and certificates**, including:

- 981 Associate of Arts/Science Degrees
- 212 Associate of Applied Science Degrees
- 391 Level I and Level II Certificates

Completion data for AY 2025 marks a **2.6% increase** in total credentials awarded compared to AY 2024.





Aspen Board-CEO Collaborative

In December 2025, WCJC participated in the Aspen Board-CEO Collaborative, sponsored by the Texas Association of Community Colleges.

The Collaborative includes 10 community colleges from across the State of Texas that are committed to taking steps toward “Community College 3.0”.



What Community College 3.0 Means

- A national shift from access alone to access + completion + post-college success
- Focuses on credentials that lead to living-wage jobs and/or bachelor's degrees
- Emphasizes student momentum and labor-market alignment

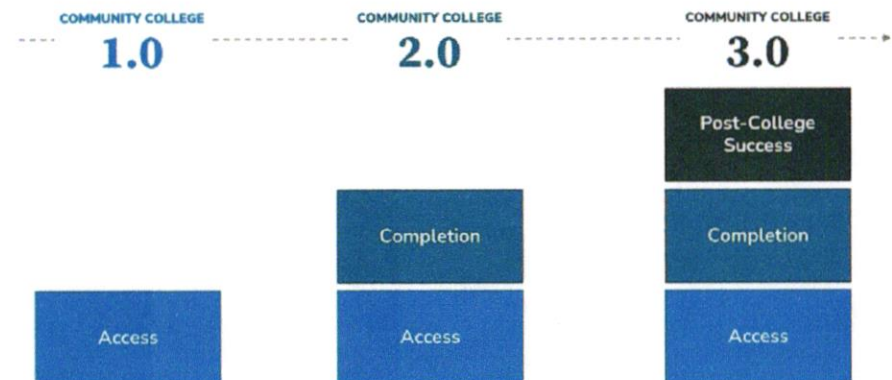
Why This Matters for WCJC

- Positions WCJC to lead in statewide and national reform conversations
