Dr. Shana Bunch-Fancher provided an update on the Special Services Department. Her presentation included spotlighting the many programs the department offers throughout the district. Teacher Incentive Allotment Update

Yarda Leflet presented updated information on the Teacher Incentive Allotment sharing an overview of the program and where the district is in the process.
