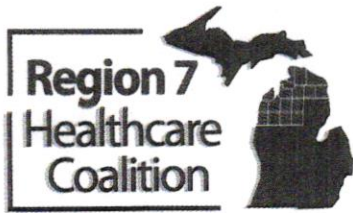
1. The ACS trailer was purchased after 911 with federal and State dollars to my knowledge the county has no financial interest.

After reviewing the documents currently available to us the Healthcare Coalition would like to request Alpena County work with us to complete the change of ownership process started in 2013, for the Alpena County ACS trailer currently stored at the Alpena County airport.

To complete the process for the change of ownership Alpena County would need to sign over the title for the trailer to the State. Once that is done myself or Lt. DeCastro could pick up the title and take it to the SOS office for processing.

With this letter we are including the following documentation to support the completion of this process. The items are a state DMB form showing that the trailer is listed as a state asset, copies of the SOS lookup form for all three ACS trailers, and an email from Mike Tilley the former HCC asst. Coordinator outlining the entire process that started in 2013 to transfer ownership of the trailers to the state under the former OPHP, now MDHHS/BETP.
