If no citation was issued, who, in your opinion was responsible for the accident and why? School Bus. Van was stopped on Grand Avenue near Everest Dr in southbound inside lane. As other vehicles in front were turning onto Everest drive from Grand Ave. The van was traveling southbound on Grand Ave near Everest Drive, the bus tried to merge into lane two and did not see another vehicle that was not involved in the crash already in the Lane. The bus merged back into it's original land and did not have time to stop. The bus hit the van.

If driver was not legally responsible, could she/he have prevented the accident by driving defensively? Explain The bus driver could have checked again for traffic before merging.

Describe the cause and results of the accident in detail. 
