The delivery of the assessments will be somewhat similar to the delivery of the TAKS in past years. The district will follow an assessment calendar that is provided by the TEA. The STAAR (including the End Of Course) system will provide the accountability data for NCLB AYP status as well as the State of Texas accountability rating system for individual schools and the district overall.
