PRIORITIZED

- 1. **Funding** increase in the state's portion of public education
- Pay/Health Insurance Benefits for School Employees an increase of \$5,000/year for teachers and/or the equivalent of that amount in health insurance assistance
- 3. **School Safety** for the state to pay for any mandates and to provide assistance for innovative approaches to school safety plans
- Testing and Accountability provide greater accountability merits for those schools with higher populations of socio-economically disadvantaged, SPED, bilingual, etc students
- 5. **Prekindergarten** fully fund all-day preK programs for all Texas children
- 6. **Career and College Readiness** require the Commissioner of Education to expand the list of CTE certifications for A-F Accountability purposes
- 7. No Vouchers no use of public tax dollars to support private education
- 8. **School Governance** return a greater percentage of educational decision making to local school boards

IN FULL

- Funding We support additional state funding (via Average Daily Enrollment) for public school students to ensure an appropriate, modern-day education for all students. Additionally, we do not support a reduction in funding for some schools in order to provide extra money for other schools. Specific needs include:
 - a. An increase in the Basic Allotment
 - b. No significant change to the Mid-Size Schools Allotment and keeping the Small-Schools Adjustment in tact
 - c. An increase in the state's share of public education (50% minimum)
 - d. Property tax relief at the local level
 - e. Increasing technology funding and flexible use of Instructional Materials Allotment
- Teacher Recruitment and Retention State leaders needs to recognize the chronic teacher shortage situation, adopt an attitude of support for teachers, and support a plan to address this major problem. Specifics include:
 - a. Increasing pay and benefits for teachers in order to improve the quality and longevity of Texas teachers
 - b. Assistance in TRS-Active Care and TRS-Care health insurance
 - c. Maintaining the defined benefit Teacher Retirement System plan
 - d. Developing a Public Relations campaign geared at promoting the value of public education, public school teachers, and encouraging young students and adult students to become a Texas teacher
 - e. Expanding the Grow Your Own grant and/or developing new partnerships to assist rural and low socioeconomic schools in attracting teachers
- 3. **School Safety** We request additional state funding and support for security, safety, and mental health needs of students, staff including training for counselors.
- 4. **Testing and Accountability** We support eliminating the A-F School Rating System, returning to a more simple system such as Met Standard, and allowing for further local accountability system development. Specifics include:
 - a. An assessment program in grades 3-8 that aligns with federal testing
 - b. Removing all high school tests with the exception of the TSI at 10th grade
 - c. Developing a local Writing Assessment in grades 4 and 7
 - d. Providing greater accountability considerations for schools who have higher populations of SPED, EcoDis, Bilingual, etc students
 - e. Require the SBOE to streamline TEKS and limiting standards to each subject and grade level that can be effectively taught prior to yearly state assessments (STAAR tests)

- 5. Full Day PreK We support complete funding for full-day PreK.
- College and Career Readiness We support a plan to further improve and expand college and career initiatives not one that restricts students to limited opportunities. Specifics include:
 - a. Continue supporting dual credit programs funding both the school district and college to finance those programs
 - b. Supporting the local determination of appropriate industry certifications for state accountability purposes
 - c. Allowing the completion of career pathways (coherent sequences) to be recognized as a component of college/career readiness
 - d. Funding 8th grade career and technology classes
- 7. Vouchers, Student Savings Scholarships, Etc We do not support vouchers or any form of public/taxpayer dollars being redistributed to private schools/education. We also do not support an expansion of charters unless they have same accountability and transparency rules as traditional public schools.
- 8. **School Governance** We support legislation that provides greater control of school district at the local level. Specifics include:
 - a. Furthering the use of Districts of Innovation and allowing for an expansion of ideas under the DOI designation
 - b. Continuing the components of HB 2610 which provides local control and reasonable flexibility of our yearly school calendars
