3. Item of information for Public Hearing to discuss proposed budget and proposed tax rate for 2025-2026

Pam Bendele presented information on the proposed budget and proposed tax rate for 2025-2026.

Questions from the public:

- Hector Gonzales commented on fund/function reporting, the \$348,000 ABC allotment, and recommended clearer communication to reflect a \$1.2 million surplus rather than a deficit.
- Simon Ortiz noted the maintenance contract is funded through the loan and, with timing differences considered, reflects a \$1.6 million surplus rather than a deficit.
- Trustee Gonzales questioned the \$447,000 transportation item, noting transportation appears to be a significant public need.
- Trustee Gonzales asked if they can go back to revisit the compensation plan.
- Trustee Rizo questioned the \$8,000 increase
- Trustee Rizo asked how the survey was promoted.

- Trustee Suarez asked how soon will pay letters would go out
  Trustee Rizo asked about the process in hiring retired teachers.
- Trustee Gonzales questioned shifting people, vacant campuses and saving money
