Pursuant to due call and notice thereof, a regular meeting of the School Board of Independent School District No. 2888 (Clinton-Graceville-Beardsley), State of Minnesota, was held in said school district on August 17, 2015, at 6:30 o'clock p.m.

Member Diekmann introduced the following resolution and moved its adoption:

RESOLUTION RELATING TO APPROVING A CAPITAL PROJECT LEVY AUTHORIZATION AND CALLING AN ELECTION THEREON

BE IT RESOLVED by the School Board of Independent School District No. 2888, State of Minnesota, as follows:

1. The Board hereby determines and declares that it is necessary and expedient for the school district to submit a capital project levy authorization to the voters for their approval. The proposed authorization will be in the amount of 0.01755% times the net tax capacity of the school district, will raise approximately \$190,000 for taxes payable in 2016, the first year it is to be levied, and would be authorized for nine (9) years. The estimated total cost of the projects to be funded by the proposed capital project levy authorization during that time period is approximately \$1,710,000. If approved by the voters, the proceeds of the capital project levy shall be used only as authorized in Minnesota Statutes, Section 126C.10, Subd. 14. The money raised by the capital project levy authorization will provide funds for the acquisition, installation and maintenance of technology and technology systems and directly related personnel costs, the acquisition of school buses, and the maintenance of school district sites and facilities. The program will be commenced prior to November 1, 2020, which date is not more than five (5) years from the date of the special election authorizing the approval of the capital project levy. The question on the approval of the capital project levy authorization shall be School District Question 1 on the school district ballot at the special election held to approve said authorization.

The actions of the administration in consulting with the Minnesota Department of Education, causing a proposal to be prepared for submission on behalf of the board to the Commissioner of Education for the Commissioner's Review and Comment and taking such other actions as necessary to comply with the provisions of Minnesota Statutes, Section 123B.71, as amended, are hereby ratified and approved in all respects.

The clerk is hereby authorized and directed to cause the Commissioner's Review and Comment to be published in the legal newspaper at least twenty (20) but not more than sixty (60) days before solicitation of bids for a capital project that has received a positive Review and Comment.

- 2. The ballot questions specified above shall be submitted to the qualified voters of the school district at a special election, which is hereby called and directed to be held on Tuesday, November 3, 2015, between the hours of 7:00 o'clock a.m. and 8:00 o'clock p.m
- 3. Pursuant to Minnesota Statutes, Section 205A.11, the school district combined polling place and the precincts served by that polling place, as previously established and designated by school board resolution for school district elections not held on the day of a statewide election, is hereby designated for this special election.
- 4. The clerk is hereby authorized and directed to cause written notice of said special election to be provided to the county auditor of each county in which the school district is located, in whole or in part, and to the Commissioner of Education, at least seventy-four (74) days before the date of said election. The notice shall specify the date of said special election and the title and language for each ballot question to be voted on at said special election. Any notice given prior to the date of the adoption of this resolution is ratified and confirmed in all respects.

The clerk is hereby authorized and directed to cause notice of said special election to be posted at the administrative offices of the school district at least ten (10) days before the date of said special election.

The clerk is hereby authorized and directed to cause a sample ballot to be posted at the administrative offices of the school district at least four (4) days before the date of said special election and to cause two sample ballots to be posted in the combined polling place on election day. The sample ballot shall not be printed on the same color paper as the official ballot.

The clerk is hereby authorized and directed to cause notice of said special election to be published in the official newspaper of the school district, for two (2) consecutive weeks with the last publication being at least one (1) week before the date of the election.

The notice of election so posted and published shall state the questions to be submitted to the voters as set forth in the form of ballot below, and shall include information concerning each established precinct and polling place.

The clerk is hereby authorized and directed to cause the rules and instructions for use of the optical scan voting system to be posted in the combined polling place on election day.

The clerk is authorized and directed to acquire and distribute such election materials and to take such other actions as may be necessary for the proper conduct of this special election and generally to cooperate with election authorities conducting other elections on that date.

5. The clerk is further authorized and directed to cooperate with the proper election officials to cause ballots to be prepared for use at said election in substantially the following form, with such changes in form and instructions as may be necessary to accommodate the use of an optical scan voting system:
