**TOPIC:** Addendum to School Liaison Officer Jr. High School Joint Agreement

**BACKGROUND:** Forest Lake Area School District currently partners with the Forest Lake Police Department in having two school resources officers. One is 12 months and one is 9 months.

**PROCESS:** Both the Forest Lake Area School Board and the Forest Lake City Council have approved a third, nine month, school resource officer.

**RECOMMENDATION:** Approval of addendum to add a third nine month school resource officer.

THIS JOINT POWERS AGREEMENT DATED THIS 13<sup>th</sup> DAY OF MAY, 2013, IS MADE PURSUANT TO M.S. 471.59, BY AND BETWEEN THE CITY OF FOREST LAKE (CITY) AND INDEPENDENT SCHOOL DISTRICT #831 (SCHOOL DISTRICT).
