On March 1, 2016 I submitted a request to ask the board for financial help to recondition wrestling mats in the wrestling room at Minico High School. At the monthly school board meeting in March the board approved the request for \$ 14,005.68.

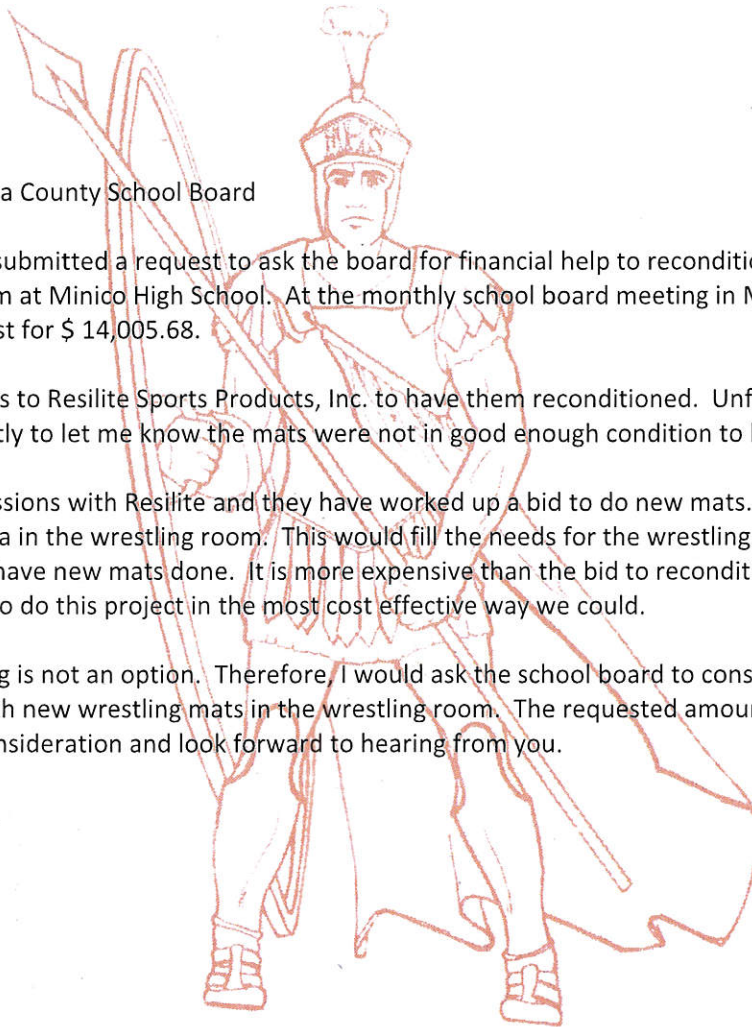
We shipped the mats to Resilite Sports Products, Inc. to have them reconditioned. Unfortunately, they contacted me recently to let me know the mats were not in good enough condition to be reconditioned.

I have been in discussions with Resilite and they have worked up a bid to do new mats. The mats would cover a 48' X 64' area in the wrestling room. This would fill the needs for the wrestling room. I have attached the bid to have new mats done. It is more expensive than the bid to recondition the old mats. We made an effort to do this project in the most cost effective way we could.

Again, reconditioning is not an option. Therefore, I would ask the school board to consider allowing us to move forward with new wrestling mats in the wrestling room. The requested amount is \$ 20,582.20. I appreciate your consideration and look forward to hearing from you.
