SERVICE CONTRACT

This Service Contract, hereafter referred to as "Contract" is made and entered into on the Contract Start Date shown above by and between Education Service Center, Region 20, hereafter referred to as "ESC-20" and UVALDE CISD, hereafter referred to as "Client".

AMENDMENT 1

AGREEMENT

1. Services to be performed by ESC-20 - School Financial Services Support for Uvalde CISD from December 15, 2025 - ~~March 31, 2026~~ August 31, 2026

2. Contract Period - The period of this Contract is that period of time commencing on **December 15, 2025** and concluding on **March 31, 2026 August 31, 2026** stated above, unless sooner terminated or extended by agreement of both parties.

3. Compensation - Client shall pay a fee to not exceed ~~\$26,000.00~~ **\$104,000.00** (Onsite Services: \$1,400.00/per day, Virtual Services: \$150.00/per hour) for the services described above. ESC-20 will bill the Client and payment is due within 30 days of the invoice date.

4. Right of Termination - Each party shall have the right to terminate this Contract upon 12 days prior written notice. In the event this Contract is terminated, ESC-20 is entitled to all fees earned to the date of termination.

5. Assignment - ESC-20 and Client acknowledge that the services rendered by ESC-20 under this Contract are unique and personal. Therefore, neither party may assign any rights or delegate any duties under this Contract, without the other party's prior written consent.

6. Health Protocols - Both parties agree to adhere to the minimum safety and health standards as defined by local, state, and federal government. In the event that COVID-19 social distancing (or other restrictions imposed to address health concerns) impacts the ability to deliver a face-to-face professional development/training event, ESC Region 20 reserves the right to cancel, reschedule or modify the event for virtual delivery, upon review of facilities and attendance. The cost allocation agreed upon may differ due to the modifications that are made for the alternate delivery method.
