Care Coordination Agreement

This Care Coordination Agreement effective on 10/04/19, is between Camino Real Community Services and Eagle Pass Independent School District (EPISD) for the purpose of care coordination, streamlining referrals, and maximizing access to community resources by preventing duplication of services.

RESPONSIBILITIES OF CAMINO REAL COMMUNITY SERVICES:

- Provide patient centered and trauma informed mental health services, intellectual & developmental disability services, or early childhood intervention services for youth and families.
- Refer to outside resources as necessary
- Provide referrals for **EPISD** prevention services for at-risk youth and their families
- Camino Real Community Services agrees to work with EPISD to expedite emergency referrals for students in crisis.
- Camino Real Community Services agrees to coordinate services for families and students of EPISD.

RESPONSIBILITIES OF EAGLE PASS INDEPENDENT SCHOOL DISTRICT:

- Refer families to Camino Real Community Services who may need mental health services, intellectual & developmental disability services, or early childhood intervention services.
- Eagle Pass Independent School District agrees to coordinate follow up with Camino Real Community Services to facilitate enrollment and engagement of students/families in Camino Real Community Services.
- Eagle Pass Independent School District agrees to coordinate follow up with Camino Real Community Services to the extent feasible, to avoid a duplication of services
- Follow up on provision of services.

This agreement between Camino Real Community Services and Eagle Pass Independent School District shall be from 10/05/2019 – 10/05/2020, unless terminated by mutual agreement. Both the Camino Real Community Services and Eagle Pass Independent School District agree to abide by this Care Coordination Agreement; which is not legally binding but designed to ensure a positive working relationship between both parties.
