RATIONALE:

This budget amendment is for the District's engaged services of Purdue Brandon to complete and submit the Property Value Study audit results to the Comptroller's Office for the 2020 tax year. As a result, the District's revenue was increased by \$2,277,521 for the 2024-2025 fiscal year. The cost of the services provided by Purdue Brandon are based on 7.5% of the amount of increased revenue to the District, which is estimated to \$170,815 but no more than \$173,000.
