

## **2.5 APPROVAL OF AGREEMENT FOR ATHLETIC TRAINER SERVICES**

### **A. SUBJECT**

This item is included on the agenda so the Board can approve the renewal of the athletic trainer services agreement for the 2026-2027 school year.

### **B. INFORMATION**

Northwestern Medicine Regional Medical Group has provided the District with athletic training services since 2014-15 when the group was under Centegra Health Systems. Three years ago, the payment schedule was changed. The District retained the same familiar trainers but rather than paying an annual flat fee, services are billed based on hours of service provided. District Athletic Directors agree that this arrangement results in a lower cost to the District. Furthermore, the District retained the stability of working with trainers who are accustomed to and familiar with our staff and procedures.

This contract bills for services rendered at \$20/hour per trainer. Through April 30, 2026, under this contract, the District has paid \$40,110.00 for services this year. The billing period is not complete, therefore additional invoices are expected.

### **C. RECOMMENDATION**

Based upon the stable and positive relationship the District has with the Northwestern Medicine Regional Medical Group the Superintendent recommends approval of the Northwestern Medicine Regional Medical Group (RMG) Agreement for Athletic Trainer Services for the 2026-2027 school year.

**THIRD AMENDMENT TO THE  
PROFESSIONAL SERVICES AGREEMENT**

THIS THIRD AMENDMENT (this “**Amendment**”) is made as of July 1, 2026, by and between **Central DuPage Physician Group d/b/a Northwestern Medicine Regional Medical Group**, an Illinois not-for-profit corporation (“**RMG**”) and **Board of Education of Woodstock Community Unit School District 200** (“**District**”) (RMG and District individually, a “**Party**” and collectively, the “**Parties**”) and amends the Professional Services Agreement dated May 30, 2023, as amended (the “**Agreement**”), by and between the Parties.

**WHEREAS**, the Parties desire to modify certain terms of the relationship set forth in the Agreement;

**NOW THEREFORE**, in consideration of the mutual promises contained herein and other good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Recitals. The recitals above are incorporated herein by reference.
2. Term. The term of the Agreement set forth in Section 2 is hereby extended through **June 30, 2027**.
3. Remainder of the Agreement. Except as amended or modified by this Amendment, all other terms of the Agreement remain in full force and effect. If there is any discrepancy between a term as modified by this Amendment and the remaining terms of the Agreement, the resolution of the discrepancy shall be controlled by the terms of this Amendment.
4. Effective Date. This Amendment is effective July 1, 2026.
