## RESOLUTION AUTHORIZING AND **DIRECTING THE TRANSFER OF MONEY** FROM THE OPERATIONS AND MAINTENANCE FUND TO THE CAPITAL PROJECTS FUND

WHEREAS, Section 17-2A of the School Code, 105 ILCS 5/17-2A, provides a procedure for interfund transfers when the transferee fund is not specifically set forth in another School Code provision. WHEREAS, the District appropriately noticed the interfund transfer hearing on July 22, 2019, which is at least seven (7) and not more than thirty (30) days prior to the hearing in the \_\_Daily Herald\_\_\_\_\_\_, a newspaper of general circulation within the school district setting forth time, date, place, and subject matter of the hearing: WHEREAS, appropriate notice also was posted 48 hours prior to hearing at the District's principal place of business, which also is the location at which the meeting was scheduled; WHEREAS, the hearing took place as noticed; and WHEREAS, there presently is One Million Dollars (\$1,000,000) in the Operations and

Maintenance Fund which is not needed for any purposes; and

WHEREAS, there are Capital Project obligations for which the funds are necessary NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Wood Dale School District No. 7, DuPage County, as follows:

It is in the best interest of the District to transfer up to One Million Dollars Section 1. (\$1,000,000) from the District's Operation and Maintenance Fund into its Capital Projects Fund. Section 2. This Resolution shall take effect on the 15th day of August, 2019.
