The regular meeting of the School Board of Independent School District No. 831, Forest Lake, Minnesota, was called to order by President Rob Rapheal at 7:00 pm on Thursday, April 5, 2018 in the Forest Lake Area Senior High School Media Center. The Pledge of Allegiance followed.
