8.1 Legislative Update:

Governor joins multi-state lawsuit:

Governor Tony Evers has joined a multistate lawsuit against the US Department of Education (USDE) for withholding federal funds from states that do not comply with a letter requesting state education agencies to certify compliance with Title VI. The suit, filed in Massachusetts' U.S. District Court, includes 18 states, including Wisconsin, New York, Illinois, Massachusetts, California, Minnesota, Colorado, Connecticut, Delaware, Hawaii, Maryland, Michigan, Nevada, New Jersey, New Mexico, Oregon, Rhode Island, Vermont, and Washington.

Public hearings for bills on rehiring retired annuitants and sexual abuse education:

Two legislative committees held a public hearing on two bills affecting school boards and K-12 education. SB 170 allows WRS annuitants to return to work without suspending their annuity, while AB 156 requires sexual abuse prevention education in grades 4K-12. SB 170 allows rehired annuitants in the Wisconsin Retirement System to continue receiving their annuity for up to 60 months, while AB 156 requires school boards to provide a child sexual abuse prevention instructional program to pupils in grades 4K-12.

12.3 2025-2026 Delegation of Leasing Authority – Dr. Robinson & Norris

Approve the 2025-2026 Delegation of Leasing Authority to approve, authorize, and direct the Superintendent and Assistant Superintendent, for a period of one (1) year, to take all necessary and appropriate actions and make all necessary and appropriate decisions in their business judgment on behalf of the District in connection with the negotiation of any amendments, extensions, renewals, or other modifications to, and the enforcement of, existing leases with tenants located at the properties owned by the District, and including, but not limited to, initiating and taking appropriate actions to enforce the District's rights and tenant's obligations under any such leases. 12.4 Independent Hearing Officer Agreement for Student Expulsion Hearings – Dr. Robinson

Approve Attorney Aleah M. Loll to serve as the Independent Hearing Officer for the 2025-2026 school year effective July 1, 2025, for purposes of conducting student expulsion hearings.

Motion by Keller, second by Lee to approve the Independent Hearing Officer Agreement for Student Expulsion Hearings. Motion carried unanimously.

12.5 Designating South NOW as the Paper to Publish Board Minutes – Dr. Robinson

Approve designating South NOW as the paper to publish Board minutes.

Motion by Lee, second by Verbos to approve designating *South NOW* as the Paper to Publish Board Minutes. Motion carried unanimously.

12.6 Seek Position on the CESA #1 Board of Control (3 yr. term) – President & Dr. Robinson

Consider seeking a seat on the Board of Control with CESA #1. This would be an At-Large Seat for a three-year term.

Motion by Keyser, second by Leigh to approve seeking a CESA #1 Seat on the Board of Control. Should the District be selected, CESA #1 Delegate Keyser would hold the Seat. Motion carried unanimously.

12.7 Adoption of Neola Policy 5411 (New) Third Grade Promotion & Retention: At-Risk Students – Dr. Robinson Adopt Neola Policy 5411 (New) Third Grade Promotion and Retention: At-Risk Students to remain in compliance with Act 20 and the DPI model.

Motion by Keller, second by Lee to approve the adoption of Neola Policy 5411 (New) Third Grade Promotion & Retention: At-Risk Students. Motion carried unanimously.

12.8 Temporarily Waive Board Policies in Support of City of West Allis Event (July 4, 2025) – Strasser

Approve temporarily waiving Board Policies 3122.01 and 4122.01 - Drug-Free Workplace and Board Policy 7434 - Use of Tobacco and Nicotine on School Premises, and Board Rule 830 Rule-2 - Facility Usage Policy and Procedures, for the dates of July 4, 2025, and July 5, 2025 (rain date) on the West Allis Athletic Complex and Nathan Hale High School Grounds. Administration further recommends the board consider adopting policy in the future to approve this specific request, activity, and purpose on an annual basis.

Motion by Keyser, second by Keller to approve temporarily Waive Policies 3122.01, 4122.01, 7434, and 830 Rule-2, for a City of West Allis Fireworks Event on School District Property. At this time, the Board will not consider adopting policy in the future to approve this specific request, activity, and purpose on an annual basis; however, the Board will reconsider this decision if presented with suggested policy verbiage and reasoning that has been vetted by legal counsel. Motion carried unanimously.

13. Workshop(s):

13.1 Deeper Learning Virtual Academy (DLVA) – Dr. Smith & Dr. Schneider

DLVA school leader Dr. Smith and ELA teacher Dr. Schneider presented the DLVA Alternative Education Competency Pathway Proposal. Fifth-Eighth grade teacher Ms. Sykora also assisted with preparing the proposal. Students who satisfy the requirements described in the proposal will be awarded a high school diploma by the West Allis-West Milwaukee School District. Upon Board approval, the proposal would be submitted to the Department of Public Instruction (DPI) under the authority of the School Board of West Allis-West Milwaukee and the Governance Board of the Deeper Learning Virtual Academy. The Board will take action on this matter at the May 19, 2025, Board meeting.

13.2 Leadership & Learning: 6-12 Math Curriculum – Burrage & Laurishke

Director of Leadership and Learning Alyssa Burrage and Coordinator of Secondary Instruction Chris Laurishke gave an overview of the proposed adoption of the Carnegie Learning math curriculum for grades 6–12. Representatives from Carnegie Learning were also onsite to answer questions. After piloting both Carnegie Learning and McGraw-Hill Reveal, the team recommended Carnegie due to its student-centered approach, real-world application of concepts, and support for collaboration and mathematical discourse. The curriculum follows a structured lesson model (Engage, Develop, Demonstrate) and offers flexibility in pacing. Staff feedback, student engagement, alignment with standards,

and support from instructional coaches drove the final decision, which also includes updates to pacing guides and summer training to prepare for a full rollout. The adoption is part of the district's ongoing curriculum cycle and comes with an 8-year, \$1 million investment, including teacher materials, student access, and professional development. To ensure smooth implementation, the plan includes 26 days of coaching over the first two years, and the district is building internal capacity through leadership training and revamped onboarding for new teachers. The Board will take action on this matter at the May 19, 2025, Board meeting.
