For the past 25 consecutive years the number of student athletes have continued to rise in our district and across our nation. With the ever-increasing numbers of athletes and continued expansion of athletic opportunity for our students the need to ensure their safety has never been greater. Each year about a dozen athletes die playing or practicing high school sports in the U.S. with thousands more suffering injuries, many of which are career ending. Research suggests that many fatalities and long-term injuries could be prevented with greater student access to athletic trainers and adopted other important health safety protocols. It is vital that our students and schools have access to appropriate sports medicine care during practices and games.

We put our Athletic Trainer Services out to Bid. Based on the RFP, I propose that we award this bid for Certified Athletic Trainer Services to Intermountain Health. We would like to contract with them for up to a 5-year period at a cost of \$16,500 per year, per high school increasing to a final year (5th year) of \$22,500 per year per school. Intermountain Health will provide, through its assigned Athletic Trainers, **1.5 FTE each academic year to each of the School District's sponsored High Schools**. This will include one Full-Time Athletic Trainer at each participating High School and one Part-Time Athletic Trainer that will coordinate hours with assigned Full-Time Athletic Trainer and Schools Athletic Directors/Administration on appropriate secondary coverage hours each week.

Price Guarantee Period

Proposed pricing structure outlined in section B of this Cost Proposal will guarantee pricing in the first year of the contract period. There will be a proposed variable annual inflation increase in cash payment amount each year starting in year 2 of the contract (2025-2026 school season). Extended Coverage outside of Contract

If School desires to have athletic training coverage for events that fall outside of the scope and qualification of established Contracts and RFP, Intermountain is willing to consider providing athletic training coverage for an hourly reimbursement rate of \$40.60
