## Applying for 2025-2026 Federal Entitlements

The Uvalde Consolidated Independent School District hereby gives notice to the public that it intends to apply for federal entitlements under the Elementary and Secondary Act (ESEA): Every Student Succeeds Act (ESSA), Special Education Consolidated (IDEA B) & Perkins V: Strengthening Career and Technology Education for the 21st Century entitlement for grant year 2025-2026.

The following grant entitlements are estimates based on the funds for the 2024-2025 school year with a 10% decrease due to changing awards amounts anticipated by the United States Department of Education (USDE) for Uvalde CISD.

- Title I, Part A: est: \$1,939,391- Provide supplemental resources to help schools with high concentration
  of students from low-income families acquire the knowledge and skills in the state content standards and
  to meet the state-student performance standards.
- Title II, Part A: est: \$232,179 -Increase student achievement consistent with the challenging State
  academic standards, improve the quality and effectiveness of teachers, principals and other school
  leaders.
- Title III, Part A est: \$28,223 Develop programs for limited English proficient students to attain English
  proficiency, develop high levels of academic attainment and meet the state content standards and student
  achievement standards.
- Title III, Part A Immigrant: est \$99,570 Provides supplemental funds to school districts who are experiencing substantial increases in immigrant children and youth for activities that provide enhanced instructional opportunities for immigrant children and youth. Funds are intended to assist youth attain English proficiency and develop high levels of academic achievement in English. \*\*\*\* We are part of the Region 20 commitment this amount is dedicated to Region 20 contracts\*\*\*\*
- **Title IV**, **Part A est:** \$154,071 Student Support and Academic Enrichment Program (SSAEP) is to improve student's academic achievement by providing all students with access to ac.
- Special Education Consolidated Grant: IDEA B Formula est \$ 872,906 IDEA B (Early Childhood Intervention) Preschool est \$ 200 Deaf Ed est \$193,195. The Individuals with Disability Education Act (IDEA) is a law that makes available a free appropriate public education to eligible children with disabilities throughout the nation and ensures special education and related services to those children.
- Strengthening Career and Technical Education for the 21st Century: est \$77,951– Perkins V represents an important opportunity to expand opportunities for every student to explore, choose and follow career and technical education programs of study and career pathways to earn credentials of value.

Grant Application Due Date: Grant application due by June 30, 2025.

Deadline for Question/Comments on the 2024-2025 ESSA grant application is Monday, June 9, 2025.
