Organizational Board Meeting Minutes January 3, 2023 - 1:00 p.m. Howard Male Conference Room

The Alpena County Board of Commissioners met in an organizational session in the Howard Male Conference Room on January 3, 2023 at 1:00 p.m. The meeting was called to order by County Clerk Keri Bertrand who called for the Pledge of Allegiance to the Flag of the United States of America.

Moved by Commissioner Karschnick and supported by Commissioner Fournier to adopt the agenda. Motion carried.

NOMINATIONS FOR CHAIRMAN OF THE BOARD FOR 2023

Commissioner Konarzewski made a motion to postpone election of Chairman until the end of the month and supported by Commissioner Osmer. RESOLUTION #23-01 Act 20 of the Public Acts of 1943 Treasurer

WHEREAS, Act 20 of the Public Acts of 1943, as amended, provides that the "... legislative or governing body of a county, city, village, township, or special assessment district, or an agency, board, or commission of a county, by resolutions, may authorize its Treasurer or other Chief Fiscal Officer to invest surplus funds belonging to and under the control of the political subdivision, special assessment district, or agency, board, or commission of a county per the Investment Policy for the County of Alpena as required by Public Act 20, of 1943 as amended.

WHEREAS, it is the intent of the County of Alpena to maximize its return on balances from time to time available in the various funds of the County of Alpena; and,

WHEREAS, it has been the past practice of the County of Alpena to have its Treasurer make immediate investment of available balances;

NOW, THEREFORE, BE IT RESOLVED, that the Treasurer be authorized and is hereby directed to invest the balances from time to time available in the various funds of the County of Alpena in accordance with Act 20 of the Public Act of 1943, as amended; and,

BE IT FURTHER RESOLVED, that all such investments heretofore made are hereby ratified and validated.

RESOLUTION 23-02

Drain Commissioner Gerald Fournier gave an update reporting the Resolution 23-2 needs to be approved to be able to purchase the bond. Treasurer Ludlow explained that by approving this resolution the County is backing up this project and allowing to purchase this bond to finance this project. The Beaver Lake Dam Project was previously approved by the board along with the special assessment which will be paying for the bond payment of 10 years.

SPECIAL ASSESSMENT DISTRICT
(Alpena County, Michigan)

DESCRIBED IN THE ORDER AUTHORIZING BONDS
TO BE ISSUED BY THE ALPENA COUNTY DRAIN COMMISSIONER

THE ALPENA COUNTY BOARD OF COMMISSIONERS

January 3, 2023

WHEREAS, the Alpena County Drain Commissioner (the "Delegated Authority") expects to complete the necessary proceedings for the Beaver Lake Level Special Assessment District Project (the "Project"), located in the Beaver Lake Level Special Assessment District (the "District"), in Alpena County; and

WHEREAS, the maximum estimated cost of the Project is \$595,000, which will be apportioned against lands in the District specially benefited by the Project, all pursuant to Act 451; and

WHEREAS, this cost will be financed with the issuance of the District's Bond or Bonds in the amount not to exceed \$595,000 which will be secured by a pledge of the full faith and credit of the County of Alpena.

WHEREAS, once these proceedings are completed the Drain Commissioner will sign a Bond Order for the Beaver Lake Level Special Assessment District, Series 2023, authorizing the issuance of not to exceed \$595,000 series 2023 Bond or Bonds (the "Bonds or Bonds") with interest at a rate not more than 6% per annum pursuant to Section 307017 of Act No. 451 of the Public Acts of Michigan, 1995, as amended ("Act 451") maturing finally separately over a ten year period June 1 with the final maturity in June 1, 2032 in the form attached hereto as Appendix A; and

WHEREAS, the Board of Commissioners, pursuant to said Act 451, is authorized by vote of two-thirds of its members to pledge its full faith and credit of the County of Alpena for the payment of the Bond or Bonds, within constitutional limitations; and

WHEREAS, the Bond or Bonds will not be a private activity bond for purposes of Section 141 of the Internal Revenue Code of 1986 (the "Code");

NOW THEREFORE BE IT RESOLVED BY THE Alpena County Board of Commissioners as follows:

- 1. The limited tax full faith and credit of the County is hereby pledged for the prompt payment of the principal of and interest on Bond or Bonds. In case of any deficiency in the assessments to be made to pay the principal of and interest on Bond or Bonds as and when due, the County shall pay the amount of such deficiency out of its general funds as a first budget obligation and, if necessary, shall levy ad valorem taxes for such purpose against all taxable property within its limits, subject to constitutional and statutory limitations provided, however, that if it is necessary to reimburse the County for money, it is obligated to advance, it shall be the duty of the Drain Commissioner to at once levy an additional assessment as hereinbefore provided as such an amount as will make up the deficiency pursuant to Ace 451, Section 280, M.C.L. 280.280.
- 2. This Resolution shall not take effect until the Order Authorizing the Issuance of Bond or Bonds, is executed and filed in the office of the Delegated Authority and a certified copy is filed with the Alpena County Clerk.
- 3. All previous resolutions of the Board of Commissioners of the County, or parts thereof, that are inconsistent with this resolution, are hereby rescinded.

Administrator Hannah informed the board that the vacancy in District 8 seat will need to be filled within 30 days and will put out public posting, conduct interviews, and board approve a selection. Moved by Commissioner LaHaie and supported by Commissioner Konarzewski to approve advertising for the vacancy seat in District 8 and to post on the County Website, in the local newspaper, and on social media for 15 days. Roll call vote was taken: AYES: Commissioners LaHaie, Osmer, Karschnick, Fournier, Francisco, Konarzewski, and Peterson. NAYS: None. Motion carried.

NEW COMMISSIONER LAPTOPS UPDATE

Chairman Peterson requested IT Director to give an update on the new commissioner's laptops. IT Director Steve Mousseau reported they will be completed in a couple of days and can be picked up by this Friday. Kevin Osbourne of Alpena presented to the board his recommendation to fill the Community Corrections Advisory Board as soon as they can and their next meeting will be in April. Kevin shared his interest in serving on the Parks Commission Board reporting he was not considered an applicant to interview.

Moved by Commissioner Karschnick and supported by Commissioner LaHaie to adjourn. Motion carried. Meeting adjourned at 1:48 p.m.
