Re: Network Infrastructure Components – Network Switches

Please submit this recommendation for purchase to the BOE for the April 24, 2017 meeting.

I am recommending the purchase of 25 HPE 1950 network switches, capable of providing Power over Ethernet (PoE) and high speed connectivity. These switches are key components of the voice system replacement project and will support IP-based phones, voice calls, wired/wireless network traffic in several locations throughout the District.

This equipment will be used to support teacher access to Internet-based resources and can support the wireless network used by staff and students. Funding support will be requested through the E-Rate program to help offset the cost of the network switches. To this end, the District followed the E-Rate procurement process to receive competitive bids on the equipment being requested. Five bids were received. Through evaluation, the result of which is below, with the Board's approval I recommend that the purchase be awarded to Paragon Development Systems, Inc. (PDS).

The following table details the total cost of the equipment. This purchase consists of equipment only as the installation and configuration will be performed by District Technology staff.

Should the request for E-Rate support be approved by the FCC/USAC, the District estimates a reimbursement during the 2017-18 school year of approximately \$11,129.

Funds which were identified in the 2016-17 Capital Plan for Network Improvements will be used to purchase the equipment in full.
