Water Treatment Services Contract Agreement

This agreement is made effective by and between Cedar Hill ISD, 912 Cedar Street, Cedar Hill, Texas and WESCO Chemicals, Inc., 103 Industrial Drive, Waxahachie, TX 75165.

In this Agreement, the party who is contracting to receive services shall be referred to as Cedar Hill ISD and the party who will be providing the services shall be referred to as **WESCO** Chemicals, Inc.

WESCO Chemicals, Inc. has a background in water treatment programs. These programs consist of chemical formulations for each client, with monitoring and analysis services.

Cedar Hill ISD desires to have these program services provided by WESCO Chemicals, Inc.

Therefore, the parties agree as follows:

WESCO Chemicals Inc

- 1. DESCRIPTION OF SERVICES. Beginning December 1, 2010, WESCO Chemicals, Inc. will provide service and chemicals as stated in Appendix A, as per attached.
- Cedar Hill ISD will pay a fee to WESCO Chemicals, Inc. of \$729.74 per month, (breakdown in Appendix A) plus any applicable sales tax, and necessary fuel surcharges. The current fuel surcharge of 3% is an additional fee per month, for services and including chemical deliveries. Existing fuel surcharge is dictated by the gas fluctuations of the economy and may change accordingly. Payment is due within 30 days after date of invoice. At any time Cedar Hill ISD becomes 60 days past due, account may continue within C.O.D status.
- 3. TERM/TERMINATION. This Agreement shall be effective for a period of ONE (1) year(s) and shall automatically renew for one additional year, with monthly payment being reduced to \$589.00 per month, unless either party shall provide 30 days written notice to the other party prior to the end of initial term of contract. Either party may cancel this contract with a 30 day written "Notice of Termination" letter. termination must include viable reason for such termination. The party placed upon notice will then have 30 days to alleviate said issued to acceptable levels, prior to termination. If notice of cancellation letter is issued within first year of contract, an invoice will be issued for the balance of equipment due.
- 4. ENTIRE AGREEMENT. This agreement hereto comprises the complete agreement of the parties respecting the services to be performed. No engagements, promises, representations, or warranties have been made by either party except, as is expressly stated in this Agreement and Attachments. All modifications to this Agreement shall be in writing, signed by both parties hereto.
