

### December Board Report Dr. Keri Launius, Executive Director of Academics

January was a pivotal month for the Academics Department, characterized by a strong launch to the second semester, strategic leadership support during transitions, and the expansion of key workforce partnerships. We launched the new semester with a district-wide Professional Development Day on January 5th. Facilitated by district leadership and our Region 4 partners, this day was dedicated to deep "data digs" and strategic planning.

Campuses utilized this time not only to analyze end-of-semester data but to translate that data into action. Teachers and leaders collaborated to:

- Identify specific student misconceptions from the fall semester.
- Calibrate instructional focus for the upcoming grading period.

To ensure fidelity in our instruction, we collaborated closely with Region 4 Product Advisors and LASO leads. Our primary objective was training campus leadership on a unified set of expectations for curriculum internalization regarding the Bluebonnet curriculum.

The Academic Support Team (AST) has been fully deployed to provide stability and guidance during recent leadership transitions. A primary focus has been the revitalization of instructional practices at Stewart Elementary. We have established Instructional PLCs directly supported by district staff. These are not just meetings, but working sessions used to analyze student work samples and align teaching strategies in real-time. These PLCs are the driving force behind the implementation of a new, comprehensive intervention plan. This plan includes targeted small-group instruction and weekly progress monitoring designed to rapidly close achievement gaps in reading and math.

In the secondary realm, we are excited to announce a continued and strengthened partnership with the Houston Port Authority. We met to discuss the future of our CTE Maritime Transportation program.

This collaboration is looking to become a cornerstone of our Career and Technical Education strategy. It will provide our students with robust, real-world opportunities—including potential site visits and mentorships—creating a direct pipeline to high-demand, high-wage careers in our local economy.



## Board Report

Sarah Saenz, Curriculum Coordinator

Over the past two months, deliberate efforts have been made to remove instructional and operational barriers for both administrators and teachers. Bluebonnet pacing calendars were consolidated into a single, user-friendly document to support administrators during walkthroughs and PLC observations. Additionally, following collaborative meetings with Bluebonnet Product Advisors and campus administrators, a comprehensive one-page resource was developed outlining expectations for Bluebonnet internalization in both mathematics and RLA. This resource includes detailed exemplars and guiding questions to support instructional coaching conversations. To further support instructional alignment, an academic vocabulary reference was also created to identify the specific terminology teachers should be using for each lesson.

In conjunction with these efforts, frequent instructional walkthroughs have been conducted across all K–12 campuses to gather data on current academic performance and the fidelity of Bluebonnet implementation. These walkthroughs have resulted in targeted coaching conversations with both teachers and administrators, focused on strengthening instructional practices and maximizing student learning.

Walkthrough data has also informed the development of multiple professional development sessions. On Monday, January 5th, professional learning was facilitated on the consistent use of the ACE strategy across classrooms, increasing student engagement, and strengthening Bluebonnet internalization practices. Additional sessions addressed the effective use of academic vocabulary and the analysis of assessments to identify priority TEKS, develop purposeful questioning, and calibrate the rigor of Learning Intentions (LIs) and Success Criteria (SCs) to enhance instructional outcomes.

Currently, the Academic Support Team is analyzing data to determine an effective structure for intervention time at Stewart. This work includes the creation of small groups aligned to high-priority TEKS and the facilitation of targeted mini-professional development sessions. These efforts are designed to ensure that all teachers are equipped to use intervention time effectively and that every student receives instruction aligned to their individual learning needs.

#### Human Resources:



#### **Baseball**



### **December 2025 SRO Monthly Report**

#### **Monday, December 1st**

- Two students entered the perimeter fence at SES over the Thanksgiving break. One of the students pushed sticks into the lock tumblers of doors #2 and #4, resulting in the locks being jammed. The students were identified and issued complaints for criminal trespass. One student attends SES and the other attends CMS, admin of each campus was notified.
- Investigation into a reported verbal altercation that possibly turned physical in the locker room at CMS. No evidence was found to support the claim that the argument became physical. The incident was turned over to admin.
- Officer was advised by a former student that the father of a current HS student has been posting online about an ongoing issue between 4 current HS students. This issue has expanded to where Hitchcock PD has also investigated allegations. This incident did not occur on campus, but was documented due to the continuing issues.
- Received a report that a HS student held a meeting on social media and ingested a large quantity of pills. A brief investigation revealed that the student was in the hospital for an overdose. This incident did not occur on ISD property, but was investigated for student safety

#### **Tuesday, December 2nd**

- A HS student reported that he rode home with family after the football game on 11/21 and left his equipment and some personal property with the team. When the student returned after the Thanksgiving break, he located his equipment bag in the locker room and found that a shirt, a pair of gloves, one cleat, and \$40 were missing. The incident was turned over to the coaching staff to look into.
- Officer accompanied the McKinney-Vento Liaison to 6607 Prino St. for new student paperwork.
- Two HS students engaged in a verbal altercation and began to approach each other when an officer intervened to prevent escalation. No offense occurred, the incident was referred to admin.

#### **Wednesday, December 3rd**

- A HS student threw an egg in the main hallway during transition resulting in a mess. Video footage was found of the student that threw the egg, incident referred to administration.
- A PES student reported that he was tired due to having to watch his 5-year-old and 2-year-old siblings at home alone. Campus administration was advised to report the information to CPS.

#### **Thursday, December 4th**

- Officer had to intervene in a verbal disturbance between HS students. Officer had to assist with escorting one student back to his classroom when he refused to cooperate and again attempted to provoke the other student. The incident was referred to administration.
- An investigation was initiated due to the rumor that an inappropriate video involving two HS students was circulating around the campus. Several HS students were interviewed and it was learned that the video was recorded recently, however, there is no evidence that the video was digitally shared.
- Administrative search of an HS student due to setting off a restroom vape detector. No contraband was found; however, it was learned that the student had skipped class and remained in the restroom for approximately one hour.

#### **Friday, December 5th**

- A HS student reported that another student violated a stay away agreement by following her into the 300 hall restroom and calling her derogatory names. The student ignored the provocation and was called the same derogatory name when she left the restroom. Referred to administration for violation of the stay away agreement.
- Investigation was conducted based on a P3 tip that two HS students nearly got in a fight in the weight room. The tip indicated that they planned to fight after school. One of the students was taken to the office, incident was referred to administration.
- During release at the HS a cafeteria worker was struck in the head by a shoe that was thrown. Footage of the incident was found and the student that threw the shoe was identified. The worker that was struck requested that charges be filed. The student was issued a complaint for misdemeanor C assault by physical contact.

#### **Monday, December 8<sup>th</sup>**

- HS student reported that another student called him extremely offensive and derogatory names on two occasions in the same day. The student was offended and advised officers that he fears if the conduct continues it will lead to a fight. The student's parent was contacted and they declined to file disorderly conduct – language charges. The incident was referred to administration.
- Officer had to intervene in a verbal disturbance between students in room 208. The incident was found to be verbal only. The students were separated and referred to administration.
- HS student made a comment about self-harm during lunch. While the comment was believed to be a joke, the student was still referred to the campus counselor.
- Officer responded to a HS classroom after a report of a fight. Both students were escorted to the office where they claimed that while they did push and slap each other, it was merely horseplay. The incident was referred to administration.

#### **Tuesday, December 9<sup>th</sup>**

- A special needs student at the HS reported that her brother yells at her and touches her in inappropriate places. The student advised that her brother has since moved back to Honduras and no longer lives in the home. A CPS report was completed and the investigation was turned over to the Hitchcock Police Department.
- Administrative searches of two students were conducted based on two vape detector alerts. No contraband was located.
- Threats were made to several schools in the area. The Sheriff's Office notified every district in the County of the threats. One threat was that a male was in a vehicle in the parking lot of an undisclosed campus with a firearm. The male advised that if he did not receive \$100,000 in 30 minutes, he would shoot up the campus. Increased patrols were conducted at each HISD campus during dismissal as a precaution.

#### **Wednesday, December 10<sup>th</sup>**

- Officer responded to a male yelling in the HS 200 hallway. Officer found a teacher attempting to get a student to go back to class. The student was yelling and using profane language. The student was escorted to the office, incident referred to administration.
- HS student left the campus and walked to CMS to check on his sister, whom he claimed was being bullied. Once at CMS the student did engage in an argument with Principal Line. Once the argument was over, he student opted to walk home. This incident was referred to HS administration.
- Officer was called to the central office due to an irate female in the lobby. The female informed the officer she was upset because it was taking too long to get her ID back. Office staff informed the officer that they were unable to fulfill the female's request and they believed she smelled of marijuana, so they wanted an officer present when they returned her ID. Once the ID was returned, the female left the campus.

#### **Thursday, December 11<sup>th</sup>**

- Two PMS students engaged in a fight on the playground. A teacher was able to stop the altercation and take the students to the office. Neither student has reached the age of culpability, so admin handled the incident.
- HS Officer provided CPS more information regarding a previous CPS report.
- HS Officer received information of teachers transporting students off campus. Video of the previous two weeks was reviewed and pertinent footage was provided to campus and district administration. Nothing criminal was found during the investigation, referred to administration.

#### **Friday, December 12<sup>th</sup>**

- A known female entered the boy's locker room when the CMS boys' basketball team arrived from an out of town game. The female was able to get in through the exterior door to the locker room. The female was reported as agitated and using profanity. No physical contact was made with any student. The female was identified as a family member of one of the CMS students. The female was issued a citation for class C criminal trespass and was further given a criminal trespass warning for all district property.
- Two HS students engaged in a physical fight in a classroom. Both actors were taken into custody and transported to the Galveston County Jail for class C disorderly conduct – fighting in public. During the investigation it was found that one of the actors set up her phone to record the fight.
- During HS dismissal, police and admin were called to the student parking lot due to a physical altercation. The involved parties claimed that they were only play fighting. Video was reviewed and both students threw punches that struck the other. Each student was issued a complaint for class C disorderly conduct – fighting in public.

#### **Monday, December 15<sup>th</sup>**

- Two SES students were involved in a verbal altercation in a classroom that escalated to a water bottle being thrown and then physical contact. Students were separated and referred to administration.

**Tuesday, December 16<sup>th</sup>**

- Several HS students engaged in a verbal disturbance in the cafeteria hallway. The students were separated and referred to administration.
- A HS student was found to be in possession of a vape. The student stated that she bought it from another student by giving him an Amazon gift card. An Amazon gift card was located in the stated student's phone case. The student in possession was issued a complaint for class C possession of nicotine vape, both involved students were placed in DAEP.

**Wednesday, December 17<sup>th</sup>**

- A SES student created a disturbance in his classroom and refused to leave. The student had to be moved in his chair due to him holding on to it tightly. Once in the main hallway he further refused to walk on his own. The campus officer had to carry the student to the office. Restraint report was completed, incident referred to administration.
- An admin search was conducted on two HS students after a vape alert in the 300 hall way. One student was found to be in possession of a THC vape. The student was taken into custody for felony possession of a THC vape and transported to the Galveston County Juvenile Justice Center.
- Officer investigated a P3 report regarding missing AirPods. Video footage was found of the AirPods being dropped in the hallway and another student picking them up. Multiple students were questioned and the AirPods were found to have been turned in to the front office.


**Thursday, December 18<sup>th</sup>**

- HS student informed the campus officer that he left his AirPods in the gym after the basketball game. Officer reviewed video footage and found that no one entered the gym after the team left. Officer escorted the student to the locker room where the AirPods were located.
- Two students were subjected to administrative searches due to two separate vaper alerts. No contraband was found on either student.
- A parent was able to enter SES without checking in with the front office. The female nearly made it to the cafeteria before being stopped. She was attempting to deliver food to one of her children. This is not the first time this parent has refused to check in with the front office, further she does not have sole conservatorship of her children. The parent was issued a criminal trespass warning at the request of campus administration.

**Friday, December 19<sup>th</sup>**

- Two CMS students got into physical fight over food being taken. Incident was referred to administration.
