Consideration of sale of land gifted by the Dubray family to the Browning Public Schools be sold back to the family member by Browning Public School to Georgia Icenoggle, an

enrolled member of the Blackfeet Tribe.

A motion was passed at the Board's Regular Meeting on July 10, 2018 declaring the 2 1/2 acres of land (not accessible) located on SE1/4, SE 14, SE 14, of SW 1/4 of section seven (7), Township 37 N of range 10 West of Montana Principal Meridian containing 2 ½ acres more or less to be surplus property because it is no longer desirable or suitable for the school purposes of the district.

Accordingly, it is my recommendation that the Blackfeet Tribe allow the sale of this inaccessible 2 ½ acres be sold to the family member Georgia Icenoggle, who is an enrolled member of the Blackfeet Tribe. Georgia and her family owns all land surrounding and adjacent to the property and her family also gifted the Browning Public Schools this land in 1941 for the purpose of having school on that property.
