Discussion of Student Voice Through (AVID) Advanced Via Individual Determination-Braswell High School This information is to provide our students a 'voice' in sharing their perspectives, suggestions, and recommendations to the Board of Trustees. The Braswell High School group of students will share their thoughts as students of the AVID (Advanced Via Individual Determination) program. The objective of the program is to increase the percentage of graduates that meet the criteria for college, career and military readiness (CCMR).

- 76% of AVID seniors are from low socioeconomic status backgrounds
- 86% are underrepresented students
- 94% complete four-year college entrance requirements
- 90% who apply are accepted into four-year colleges
- 84% who enroll in college persist into the second year.

The AVID program is currently at NAVO and Rodriguez Middle Schools and Braswell High School in grades 7-10 with 73 student's total. Next year it will expand into the Freshman Academy at Guyer High School with a total of 123 total students in the AVID program.

Discussion of the "New" Newton
Rayzor Elementary
Campus and the
Calhoun Middle
School Renovations

Keith Cummings, with Corgan Architects provided the Board of Trustees with the planned renovations and changes for the "new" Newton Rayzor Elementary and Calhoun Middle School site plan. Corgan utilized responses they received from teacher and student focus groups to discover what was most important to their learning experience such as outside classroom space, collaboration space, technology etc. This strategy was used for both the elementary and middle school campuses.

Discussion of Raising Blended Learners Grant Program-Raise Your Hand Texas/Charles Butt Foundation Ross Garrison provided the Board of Trustees with an update on the progress of the Raising Blended Learners Grant Program. Raising Blended Learners is a four-year initiative showcasing strategies for using blended learning to help close achievement gaps between continuously enrolled and non-continuously enrolled students in 9th grade Algebra One. In 2019, DISD students that were continuously enrolled (CE) for four or more years were 1.53 times more likely to reach mastery level on the Algebra I End of Course assessment than students that were non-continuously enrolled (NCE). Our Raising Blended Learners grant program is designed to close the gap between CE and NCE students in Algebra I. All students enrolled in the Blended Learning Algebra I courses will demonstrate an increased attachment to their high school.

By the end of 2024, after four years, the Raise Your Hand Texas Foundation will have provided \$261,996 in grant money to Denton ISD.

This grant provides professional development for teachers and district support staff, coaching from our partners at Region 11, substitute teachers for the RBL teachers when they must be away for professional learning, computer hardware for student use, reading materials, and stipends for some district staff. It could also be used to send teachers to conferences at which they can learn more about blended learning. We currently have eight teachers participating in the program, two from each high school. The program serves approximately 950 students.

Discussion of Budget 2022-2023

Jennifer Stewart, Executive Director of Budget reviewed the 2021-2022 Hold Harmless Average Daily Attendance and the 2022-2023 preliminary property values. When the District received the preliminary values for this year there was a 26% increase on this first report. These values will decrease after protests. Ms. Stewart feels based on the historical trends the District could have a 13% increase in values. When property taxes rise, the District receives less funding from the State which is almost a dollar-fordollar loss of 13.6% funding from the State. If the State would maintain their current level of funding, then Denton ISD would be able to reduce their M&O tax rate by possibly 2 cents less.

Discussion of Texas Association of School Boards 2022-2024 Advocacy Resolutions Dr. Gwen Perkins, Area Superintendent and Deron Robinson, General Counsel provided the Board of Trustees with an update to the resolutions to be submitted for the upcoming TASB Advocacy Agenda. As the District continues to express concern and advocate for policy changes to address the capacity of public education to provide an equitable education for all Texas students, we recognize the need for continued support of those organizations supporting our community. The District also realizes the power of a unified voice and the critical intertwining of these organizations in advocating for policies impacting our students, families, and community.

The call for resolutions runs from April 1, 2022, until 11:59 p.m. on June 15, 2022. Proposed resolutions are first reviewed by the TASB Resolutions Committee and then by the TASB Board. In September, the Delegate Assembly will adopt approved resolutions.
