The cast, which performed "The Lion in Recognitions Winter," placed first in regional competition and advanced to the state level for a second time in a row. Abdiel Serrano, a fifth-grade student at Rivera Elementary, was recently honored with a THINK Nation Award by Think Through Math. Abdiel was one of 10 students across Texas recognized for his ability to solve math problems during the 2012-13 school year as part of the THINK Nation campaign.
