

Staffing Reorganization

Special Education teachers 7.0 FTE	Special Education Teachers 6.0 FTE
Additional certified staff for pandemic class sizes/dedicated remote learning sections at SHS	Reduction of 2.2 FTE approved in March with 2.0 FTE held in reserve for hiring based on kindergarten and first grade enrollment
	(Overall Reduction of 1.6 FTE = approx. \$120,000 salary/benefits)

Proposal: Add 1.0 FTE Assistant Principal of Student Support to work in both buildings (3.5 days SHS and 1.5 days RMS)

AP of Student Support Responsibilities

- Oversee student discipline in both buildings
- Oversee implementation and monitoring of multi-tier system of support (MTSS), both academic and behavioral
- Building supervision
- Non-certified staff schedules and supervision/evaluation
- Master scheduling support
- Teacher evaluation





ESSER Funding

- ESSER Funding to Date
 - Round 1: \$23,501
 - o Round 2: \$155,015
 - Round 3: \$347,973 (estimated)
- Use of funds
 - Twenty percent of Round 3 funds must be used to address potential learning loss
 - Expenses related to the opening of school
