# G.I.S. Setup

- Geocode PEIMS student database to assess current attendance patterns.
- Update street and parcel records.
- Update student yield and planning area reports.

### **New Housing Research**

• Quarterly housing research including: starts, closings, developed vacant lots and future lots.

#### **Enrollment Forecast**

- Analyze existing demographics and enrollment history for all attendance levels.
- Provide two-year enrollment forecast by campus, grade level and planning area.
- Geo-code existing student database to assess current attendance patterns.
- Compare current student database to enrollment history to analyze trend patterns.
- Provide rollup forecast using only existing students.
- Forecast population growth within the district.

## **Long Range Facility Planning**

- Provide 10-year enrollment projections by campus and grade level.
- Long range enrollment forecast will be built upon the two-year enrollment forecast.
- Subdivision yield analysis based upon geocoded students compared to parcel files will generate number of students by subdivision.
- Review single family and multifamily building patterns.
- Review the likely developments of vacant land in each attendance zone.
- Determine the future characteristics of the student population based on historical trends and future population growth.

#### **Demographic Desktop**

• Web based portal to host district reports, maps, enrollment projections and presentations.
