To the Three Rivers School District Board,

My sons Liam and Owen graduated Illinois Valley High School in 2015 and 2019, respectively. During that time, we knew several students who identified as transgender or gay, and they often discussed with us their struggles. We also knew, and still know, several students who elected not to attend Three Rivers Schools because of a perceived lack of safety and acceptance for queer students.

Owen's partner comis trans. Owen met through RiverStars
Performing Arts, an inclusive program where students were, and felt, safe and celebrated. The has avoided LBMS and IVHS, and that is a terrible loss for the TRSD community, because the is articulate, joyful, intelligent, and motivated. But the hears reports from other students, and those reports were both credible and discouraging.

Furthermore, when RiverStars was first developing, educator experienced serious discrimination from administration which was at the time in violation of TRSD policies. Had I known about the treatment he received then, I would most certainly have brought it to the attention of the district. But at that time we would have had to comb through policies to articulate precisely why the treatment was wrong. The Every Student Policy would have spelled this out unambiguously.

Policy ACBA, the Every Student Policy, currently under consideration for adoption by the board, would be a solid step towards truly welcoming students like interaction and his peers, and would protect program partners like Eliot, and staff members, too. I urge the board to adopt it and demonstrate by this action that our educator community, our vulnerable students, and all of our students, have TRSD's full support.

I realize that there will be difficulties in athletics. This is a new road and new roads are hard. Be as brave as our transgender athletes. But I do not believe there will be significant adjustment or risk associated with the use of bathrooms. I do think school bathroom design is problematic overall, but if there are incidents in bathrooms it is vastly more likely that it will be the trans kids affected, not they as the perpetrators. Frankly, our kids are way ahead of us on this issue. Other than those fed hateful misinformation, vanishingly few of them are likely to be afraid of a fellow student just looking for a quiet place to pee.

I applaud the efforts of TRSD to craft policy that truly and unambiguously supports every student as well as all staff and partners. Change is hard. Doing the right thing can be hard. You can do hard things.

I am writing in support of the ACAB-Every Student Policy.

For 7 years, I have taught for RiverStars Performing Arts in the Three Rivers Schools in the Illinois Valley. Over this time, RiverStars has become a safe haven and a "second home" for LGBTQ+ and students of color. This is not by chance. Since inception, RiverStars has actively "welcomed all" and provided safe spaces for students to express their authentic selves. This has created a trusting, honest relationship between students and staff.

I was emotionally moved when I read this policy. If adopted, this policy would address many of the horror stories I have heard as a teacher.

We know that calling transgender youth by their chosen name can reduce their chance of dying by suicide by as much as 65 percent, according to the Journal of Adolescent Health. Such a small action, so little effort. If you don't believe that students in the district contemplate suicide or ore suffering depression due to feelings of inequity or of not belonging, you aren't making authentic connections. Unfortunately, it is more common than any of us want to believe. This policy has the power to change that.

I'm an old white male with much to learn about people who are marginalized because of who they are. One group of people, those with varying gender identities, have had to sacrifice and suffer in ways I've never experienced and only recently imagined. So as my awareness began to grow, it was easy at first to doubt realities I had not witnessed.

What nudged me toward understanding was listening to some of my family members: one who is trans, others who describe themselves as "non-binary". Because I knew them well as human beings and they felt they could share their feelings with me, I could simply choose to listen and to believe them. They were grappling with how to be true to themselves while dealing with all the ways straight people like me have acted as if they didn't exist. They had been forced to think long and hard about how our society might make some changes to help them feel at least accepted, perhaps even included and equal. I had not thought much about this, so it just made sense to defer to their experiences and thoughts.


I am grateful that people composed policy ACAB. It clearly articulates changes that need to be made. It is very appropriate for schools, especially for two reasons.

Obviously, school should be a safe place for all students, who have little choice about being there. We all know this basic safety is a goal we still must strive for. We're only now comprehending how many young people have dreaded going to school because of the various punishments, some brutal and some quite subtle, that staff and students have inflicted on those who are different.

But beyond the needs of the marginalized, all students will benefit from this policy. It will educate them. Knowing students as I do, I believe they will be quicker than my generation to see the essential fairness of such policies.

The history of social change indicates that every move toward inclusion of marginalized groups, including factors such as gender, race, religion, and sexual preference, has been accompanied by fears— some understandable, but most produced by a lack of knowledge about the group in question, and a fear of change itself. Any change has unknown consequences, and we tend to concentrate on and worry about negative ones. As policies change, we'll all need to be vigilant to avoid or mitigate the negatives. But the positives will lead us toward our common goal, that young people will feel included, safe, ready to learn, and happy to be there.

Thank you for your careful consideration of this complex decision.




Dear TRSD board.

Three Rivers board will take up shortened discrimination policy

The Three Rivers School Board is taking up a whittled-down version of a policy originally intended to prohibit gender identity discrimination at its Wednesday meeting.

As the "I Resolve" controversy was unfolding in the Grants Pass School District last month, the Three Rivers board decided to pull the Every Student Policy, which is backed by the Oregon Department of Education, off its June 16 consent agenda.

The school board was asked to send comments and questions about the original draft of the Every Student Policy to Superintendent Dave Valenzuela, and since then, the policy received a makeover.



An entire section under the heading "Guiding Principles" has been deleted in the district's latest version of the policy. Statements in that section that are now gone from the policy include "Harassment and bullying will not be tolerated," "Bias incidents will not be tolerated," "Symbols of hate will not be tolerated," "Sharing confidential information without consent will not be tolerated," and "The refusal to use a preferred name or pronoun will not be tolerated."

The district's revised version of the Every Student Policy now explicitly states that students will have access and opportunity for a high-quality education "in accordance to state and federal law."

Also excised were sections on restroom/locker room accessibility and extracurricular activities, including athletics. Another statement that was axed read, "Three Rivers School District will change a student or employee's records to reflect a change in name of gender upon request."

One sentence in the previous policy was changed from "Affirm the identity of each student by acknowledging and welcoming differences" to "Assert value in the identity of each student by acknowledging and welcoming differences."

The section outlining disciplinary action for violation of the policy was also removed. Also eliminated is a request to "please speak up and speak out when you witness, see, or hear bullying, harassment, discrimination or anything that makes you or others uncomfortable."

Definitions of ethnicity and race were added, along with the Oregon Administrative Rules definition of American Indian or Alaska Native.

The new version of the Every Student Policy will be up for discussion at the district's board meeting that begins at 2 p.m. Wednesday.

Members of the community are able to speak during the community comment portion of the meeting, which is limited to 20 minutes.

Comments can also be submitted to the school board by emailing shelly.quick@threerivers.k12.or.us by noon Wednesday.

In District 7, an assistant principal and a teacher were terminated last week after lobbying against transgender equality legislation in a video that the district said violated its policies on the use of district time and equipment.

I am unaware of the percentage of youth in our county that have had suicidal thoughts, but I am sure it is higher than the national percentage. These numbers are alarming and unacceptable! Our number one job as educators is to make ALL students feel safe. If our district does not adopt a policy that is inclusive and protects all students then we are failing our most vulnerable.

TRSD Members of the Board,

Many parents and community members are realizing that we have stood back for too long and now feel the need to fight for our parental rights to remain intact. We trusted that schools would continue to run just as they did when we were children, that teachings of History, Science, Math, English, etc, was unbiased and would continue to be taught without being affected by what is going on in the world outside of school. We were wrong. We have found that many political movements are trying to infiltrate their way into what should be an unbiased educational facility, too important and valuable to be interfered with, where personal beliefs are not allowed to be spoken of to such impressionable young minds. School is where so many of our children's hours are spent, so the information they receive there is extremely important. We understand that without making our voices heard and boundaries clear, you cannot be expected to know what we need for our children, which is what has led us here.

Parental consent is most important and is woven into all other issues concerning school and the lives of our children. Each of our children are different and as parents and family, we have been with them every step of the way so far, therefore we are the specialists in their lives. Our job is to do what we feel is right for them no matter what, at times that means weighing less than ideal options to provide the best outcome. It could be said that your job description sounds the same. We need to work together. Parents need to be included in the conversation before a major change takes place. The new guidelines given by the state are just that, guidelines. They are giving the district the ability to make decisions based on what's best for their schools. This is where we hope to urge you to fight the "new normal" fear, fads, and political movements that are taking hold of many schools.

Masking is one such issue. At this time, it is not required by the State, and we want to make our position very clear on this: opt out. Masking the least susceptible population makes absolutely no sense and the negative impacts on our children far outweigh the benefits.

Required Covid vaccines are high on the list of our fears. As we see the progression of pushing vaccination, we know that this is going to come up at some point and would like to get ahead of it. Once again, parental consent is key here. By law, we are responsible for our children until they are 18 years old. We fully intend to maintain the rights that come with that; however, state law says that at 15 years old they can make their own basic medical decisions, but now the Covid vaccine is being offered to children as young as 12. This is why the health clinics that are popping up in schools have us nervous. Offering the vaccine to our younger children at school without our prior knowledge <u>and</u> consent will be seen as a hostile act against our parental rights.

Politics are everywhere and heating up fast. Up until recently, their influence was not allowed to enter the school atmosphere. We strongly believe that world politics do not belong in schools unless they are taught as part of an unbiased course in a high grade level, where they can properly be understood, and higher critical thinking can be applied. This subject is a relatively large umbrella that covers Critical Race Theory, Black Lives Matter, etc. All of these so called "movements" have been hijacked by politics, politically funded, fueled, and shoved into the faces of those that are too young to view or understand the full scope of the situation. CRT: The goals of its teachings are to promote more hatred and segregation rather than unity. BLM: Of course black lives are important and should be treated as such, but this group has strayed from its original purpose and has caused segregation and division of communities and families. There should be no place for this behavior in school and no backing by the school. Support the people, not the political group.

The school's concern with transgender children is far less complex than the media makes it. Once again, it boils down to parental awareness and consent. We are here just as you are to help guide them through their growing stages, whatever that may be, and we need to be deciding and helping them decide what is best for them in the long run. Allowing parents to get shut out of the conversation and giving our children of all ages the ability to decide for themselves, even when laws and science clearly state they are not capable of doing this, without parental knowledge and consent is not acceptable. By leaving us out of the conversation, it becomes impossible to communicate with our children about these topics because we now have no authority and can make no difference in their lives on the matter. We are left having no idea when things are not okay for them. Teachers should look for signs that they need to step in or simply make it known that they are available for help if it is needed and leave it at that, then consult the parents if there is a problem.

Gender-neutral restrooms are not safe or comfortable for any of our children. Everyone needs to be able to feel safe in the few moments a day they spend completely vulnerable in the restroom. Taking a designation plaque off a door is not going to stop the issues that may come with needing to use a different restroom. If it is determined that an alternative restroom arrangement is necessary, there is a safe middle ground, add a third option. A third restroom to be used by those who need it, will keep everyone safe and remove the anxiety and hype of the situation. They are in school to learn. School is not a place for life defining issues to develop and it does not need to be so difficult or political to keep everyone safe.

Since learning is the goal, we need to be able to help our children do just that. Schools need to maintain an open door and communication policy with parents. We want to support their education, but we have no books to refer to, no information on curriculum, and no idea what we can do to help them to understand what they are trying to learn. We need to know what is being taught in order to help them be successful.

Many of these topics may seem ahead of the times, but we don't want to be left attempting to regain our ground months after new school policies have been put into effect, as it

seems is happening with District 7 right now. Prepare for the worst and hope for the best is the thought here. Our biggest goal is to be aware of what is happening and be brought in on the decision-making process of what will happen with our children.

Considering all of this, what can we do to help? We know that our schools are underfunded and not equipped as well as they should be. Let us know what we as a community can do to help make things better at school for our teachers and children. Thank you for your time and consideration. We look forward to working with you.

I'm writing today to encourage the members of the board to vote "yes" on the ACBA "Every Student" policy.

My name is Quin Fazio-Patch. I teach 5th grade at Fruitdale Elementary school. Not only am I an educator in our district, but I'm also a student of our district. I attended Fruitdale as a kid, then Fleming, and graduated from North Valley.

I'm so thankful that we as educators know more now than we did when I was a child. I had amazing teachers to whom I am forever grateful. At the same time, as a child, I know that LGBTQ+ students had zero open support in the classroom. While other kids got to see themselves represented and celebrated in the books we read and the classrooms we inhabited, others of us didn't have that. Unintentionally, our schools taught a very distinct lesson: we were accepted, valued, welcomed at school--but only if people didn't know who we truly were.

What we learned from our community as kids was that our acceptance, protection, and love was conditional.

Because of this, I chose to come back to our district. My primary goal every day is to openly and directly PROVE to each of my students that they are accepted, protected, celebrated, and loved **because** of who they are, not in spite of it.

Now I understand that there are some big topics and important vocabulary being thrown around here. I want to reassure everyone on the board, and anyone listening, that as a professional, I am very serious about developmentally appropriate practices. Educators deal with vocabulary all the time—we know how to take big, unwieldy topics and set them up, talk about them in ways that students can access, connect with, and grow from safely. Teachers don't need to give a college-level Critical Race Theory lesson to teach accurate, honest history—history that acknowledges the mistakes of the past, while fostering empathy in our students today. The support that our district provides to our students should be unequivocal and unconditional. I'm here because I want to be the teacher that I needed as a kid. I hope today you will help me get a little bit closer to achieving that goal.

Good evening, Shelly. Please forward this email to the TRSD School Board and our Leadership Team.

I want to thank our board and leadership team for their support of all students in Three Rivers School District. As you know, LGBTQ+ youth experience higher rates of harassment, bullying, and discrimination than their heterosexual and cisqender peers. This can contribute to a host of negative outcomes for our students. In the 2020 Rogue Action Center survey of LGBTQ+ people in our region, 100% of the LGBTQ+ youth reporting experienced harassment or bullying because of their sexuality, gender, or appearance. Youth particularly named public school, public restrooms. and public transit as places they felt unsafe.

The most common concern I hear from parents and community members is for their daughter using the bathroom with a trans girl. This is a common fear that comes from a lack of familiarity with transgender people. Opponents to LGBTQ+ equality have manufactured the false "choice" pitting the safety of women and children against the need to protect transgender people from discrimination. Truly, we all care about safety in restrooms! Nondiscrimination laws have been around for a long time, and there is no increase in public safety incidents. Many transgender students face hostility, discrimination, and bullying. Forcing transgender students into restrooms that don't match the gender the live every day makes that even worse. For example, forcing a transgender student who lives life every day as a girl to use the boy's restroom puts her at risk for harassment and assault. Transgender people are much more likely to be victims than perpetrators.

I would have liked to attend the meeting on Wednesday, but that is during my workday at New Bridge!
