Other Considerations

Mr. Bauer spoke about new regulation with regard to threat assessment teams. New board policies have been adopted. Teams will be subject to annual review. The threat assessment teams will be building level. These teams are not subject to open meetings act.

Chief Bland spoke about the new law passed with police speaking with students. Police are now required to contact parents first. He is requesting parents be notified first and asked if they can come if police plan to be called.

Chief has been monitoring school cross walk areas and has noticed improvement.

Fire chief solicited feedback on last month's sirens. He also noted there will be no further "all clear" announcements.
