# Purchase of Service Special Education Teachers

### Up North Learning Center Independent School District #6099

This agreement is made and entered into by and between the Walker-Hackensack-Akeley Independent School District #113 (ISD #113) and Up North Learning Center Independent School District #6099 (ISD #6099). The term of this agreement is for the period of time from July 1, 2024 through June 30, 2025 for the purchase and provision of Special Education Teachers (4.0 FTE).

#### ISD #113 Agrees To:

- 1. Provide 4.0 FTE licensed education instruction services within the limits of the capabilities to do so, to ISD #6099. Provide said service at the location(s) agreed to by both parties and consistent with the Individual Education Plan (IEP) of the learner(s) to be served as determined by ISD #6099.
- Services include lesson planning, student instruction, IEP planning and implementation. Services as inutually agreed upon and pre-approved by both parties.
- To communicate periodically with ISD #6099 to review this agreement and services provided therein to ensure satisfaction by both parties herein.
- 4. To maintain an accounting of the services provided to include salaries/benefits and mileage and bill ISD #6099 at the hourly rate of the specialist. Mileage will be submitted directly to ISD #113 for direct reimbursement to the consultant at the current IRS rate for mileage incurred.

#### ISD #6099 Agrees To:

- 1. Upon receipt of quarterly billing, submit payment.
- Communicate periodically with ISD #113 to review this agreement and services provided to ensure satisfaction by both parties herein.
- 3. Ensure the provision of services is consistent with State and Federal special rules and regulations as they may apply to identify students served by this agreement.

#### General:

- This agreement may be amended from time to time by written, mutual agreement by both parties and is
  to be reviewed annually.
- This agreement may be canceled by either party upon 30 days written notice prior to the anniversary date of the agreement
