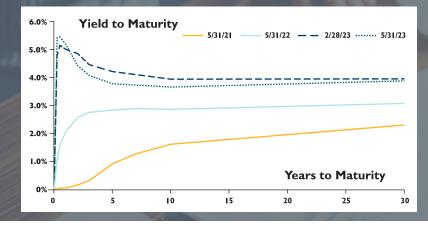

Quarterly Position Report May 31, 2023



The three-month period ending in May proved to be a volatile time for bonds as the two-year Treasury note traded in a range of 3.77% to 5.07%. In March, yields dropped sharply due to stress in the regional banking sector as Silicon Valley Bank (SVB) became the second-largest bank to fail in US history. Other smaller banks also failed shortly thereafter. In May, the focus became the debt ceiling negotiations. While a technical default on U.S. Treasury debt was viewed as a low probability event, the degree of damage to the financial markets if a default occurred still had the markets spooked. Prior to the X date (when the US Treasury would 2025. Despite the bank stress and debt limit concerns, the Federal Reserve (Fed) continued its fight against inflation, raising the target interest rate by 25 basis points at both its March 22 and May 3 Federal Open Market Committee (FOMC) meetings to a target range of 5.00% – 5.25%. At the end of May, the futures market was pricing a pause at the June 14 FOMC meeting and a hike of 25 basis points at the July 26 FOMC as the most likely scenario.
