In partnership with Parkrose School District, the Oregon Ballet Theatre drafted a program to artistically enrich Parkrose Students grades 2nd - 6th. This instruction will be piloted during regularly scheduled physical education classes so that all students can have an introduction to the art of ballet movement and live music. Thus aligning with 21-22 community engagement feedback around well rounded educational opportunities as a priority.

What unique features/functionality is required that only this source can provide?

This is the only source that offers live music during ballet instruction, therefore introducing Parkrose students to more than one art form. This is also the only source that allows students to visit performances specifically curated for their attendance.

What steps were taken to verify that goods or services with similar features and functionality are not available from other sources?

In research, there is no other local dance academy that offers a service unique to that of OBT, enriching students in multiple modes.

My recommendation for this sole source procurement is based upon an objective review of the goods and services required and is in the best interest of the District.
