

# Portland Public Schools

## Report on Compliance with Public School Standards

### 2021-22 School Year

By November 1 of each year, school district superintendents are required by [OAR 581-022-2305: District Assurances of Compliance with Public School Standards](#) to report to their community on the district's status with respect to all of the Standards for Public Elementary and Secondary Schools. The Standards are adopted by the State Board of Education and set out in Oregon Administrative Rules Chapter 581, Division 22.

The table below contains a summary of **Portland Public Schools** School District's compliance with each of the requirements of Oregon's administrative rules found in [DIVISION 22 - STANDARDS FOR PUBLIC ELEMENTARY AND SECONDARY SCHOOLS](#) during the 2021-22 school year. The additional 15 minutes is being implemented by homeroom teachers using a menu of structured movement activities aligned to PE standards. To become compliant in grades K-5 for the 2023-24 school year, staff is proposing to implement one of two options. Option 1: Have the Board modify Board Resolution 5252. Instead of a scheduled 15 minute recess, the Board would allow

			students to have a 15 minute structured time four days a week. Option 2: Have Homeroom Teachers teach an additional 45 minutes of structured movement per week. This fall and winter, staff will be engaging teachers and principals to help inform next steps to ensure compliance.
<a href="#">581-022-2263 Physical Education Requirements</a> *Middle Grades	<b>Out of compliance</b>	The district has met all of the requirements for this rule.	To become compliant in grades 6-8, the investment is significant. PPS will need to increase staffing by an estimated 50 FTE. Space is also a consideration as currently not all K-8 and Middle Schools have sufficient space for PE. Nearly every school would need an alternate space outside of the gymnasium to provide structured movement. Staff is planning to incorporate this investment into Middle School Redesign and fully implement by 2024-25 to become compliant
