I. SUPERINTENDENT'S REPORT

- A. Approval of Virgil Knowles as Temporary Chairperson to Convene this Meeting through Action Item III. A. 1: Election of Officers: A motion for approval was made by Forsyth and supported by Lohman. Motion carried unanimously.
- B. School Board Recognition Month Supt O'Neill recognized our wonderful school board and expressed his appreciation for their support and all they do for the district.
- C. Equestrian Team Mike Roy Introduced Equestrian Head Coach Mike Fleetwood who introduced his Team, who were the 2019 State Champions. He and the team answered questions from the Board.
- D. County Enhancement Millage Renewal Supt. O'Neill reminded the Board that the County Enhancement Millage Renewal will be on the May Ballot. A resolution of support is included with the packet. KRESA collects the tax and 100% of funds are distributed back to the districts in Kalamazoo County.
- E. Legislative Update News appears to be more promising than in the past with increases in funding to schools including: \$7 million for isolated districts, \$10 million in school safety grants, \$31.5 million for early literacy coaches, and \$35 million for charter school foundation allowance increases.
- F. Important Dates Supt. O'Neill reviewed important upcoming dates and reminded the Board about the Pathways Graduation on February 6, 2020.

II. REPORTS AND PUBLIC INQUIRY

A. Budget and Finance Report - Steve Goss Asst. Supt. presented the monthly progress report for December 2019 which showed total revenue of \$9,034,155; and total expenditures of \$10,786,447 and a deficiency of revenue over expenditures of \$(1,752,292).

- Bond Update Asst. Supt. Goss discussed the resolution approving the application for qualification under the Michigan School Bond Loan Fund, which will enable the school district to take advantage of the States strong credit rating. The Treasury stated the application was complete and they didn't anticipate any problem with the district receiving qualified status.
- B. Curriculum Report Gail VanDaff

Curriculum Director Gail VanDaff introduced teachers Rachel King and Jennifer Teall who presented the following proposals:

- VHS Leadership Course Proposal Rachel King HS Teacher, Rachel King gave background information on the Leadership Course proposal. It all started with the AIM Higher program. This is a national Leadership organization and will allow the students more opportunities.
- Seal of Biliteracy Proposal Jennifer Teall Jennifer Teall stated they are piloting the program now with 8 students and would like to continue and offer it to all students. This is a certification that proves students are functional in a second language—a Seal of Biliteracy.
- C. Continuing Excellence Adam Brush

Principal Brush and Asst. Principal Hawkins presented the VHS Annual Report which included information on awards and recognitions the high school has received this year. They also provided student data and an overview of programs. They reported the Social Emotional Learning PD has made a very positive impact.
