The Board adjourned into Closed Session at 6:03 p.m pursuant to sections 551.071 and 551.074 of the Texas Government code to discuss item IV-(A).

Mr. Ron Rodriguez requested not to convene into closed session.

Mr. Ricardo Rodriguez stated that this was a Special Called Meeting and we do not have any public comments.

Mr. Ron Rodriguez requested to recuse Mr. Javier Montemayor and Ms. Aliza Flores. Mrs. Mari Rodriguez stated for the record that they want to recuse Miss Aliza and Javier Montemayor. Mr. Ron Rodriguez stated this was a violation of the Texas Open Meetings Act. Mrs. Mari Rodriguez stated that they are objecting to this closed meeting. Mrs. Mari Rodriguez said "she's laughing? The board member is laughing at the parents? We're calling the media." Mrs. Christina Villarreal stated, "Wow."

V. Reconvened from Closed Session, the Board will take appropriate action on items, if necessary, as discussed in Closed Session

The board reconvened from Closed Session at 6:12 p.m.

Mr. Ricardo Rodriguez asked if there was a motion regarding outstanding and filed motions to recuse, notice of violations of the open meetings act, for the act and demand of live presentation, objection to incomplete local record and objections to ex post facto change grievance policy and request live presentation.

Mr. Juan Cruz stated the recommendation was to deny the motion to recuse, the outstanding and filed motions to recuse as they are impartial parties to these grievance proceedings. The recommendation is to deny the grievant's objections to incomplete local record as all documents they claim to be missing are either included in the local record, do not exist or not part of the local record or the grievant was not a party to the grievance filed in reference in the grievant's objection and further recommend to deny the grievant's alleged violation of the open meetings act and demand for live presentation in closed session and further recommend to deny the grievant's objection to ex post facto change in grievance policies and request for live presentation.

Mr. Ron Rodriguez stated that if they are going to allow Mr. Cruz to talk then certainly he can have an opportunity to respond.

Mrs. Christina Villarreal stated they are the parties not the public.

Mr. Ron Rodriguez stated that this was not a joke or a kangaroo court and apparently you have people that are(inaudible)

Mr. Ricardo Rodriguez asked the officer to escort Mr. Ron Rodriguez out.

Mrs. Christina Villarreal stated they are parties to this.

Mr. Ron Rodriguez stated he had a right to be here.

Mr. Ricardo Rodriguez apologized to Mr. Ron Rodriguez and stated he had been told.

Mrs. Mari Rodriguez interrupted Mr. Ricardo Rodriguez and she stated that she was going to speak as a parent and commented that Ms. Aliza Flores was partying in Las Vegas getting drunk with the grievant, the principal and that Mr. Montemayor was an ambulance chaser. While making these comments, Mr. Ricardo Rodriguez was trying to speak but was continuously interrupted by Mrs. Mari Rodriguez.

Mr. Ricardo Rodriguez stated that he could not let anyone speak at this time. He announced to go ahead and continue with the meeting.

Mrs. Mari Rodriguez stated that they will take it up in Austin with the commissioner. Mr. Ron Rodriguez was trying to speak but Mrs. Mari Rodriguez stated "let's go."

Mrs. Mari Rodriguez stated numerous times "let's go." Mr. Ron Rodriguez stated this was a joke that this whole proceeding was a joke.

Mrs. Mari Rodriguez addressed Mr. Javier Montemayor and told him he was an embarrassment to the State Bar of Texas and did not deserve to be here. She then addressed Ms. Aliza Flores Oliveros and told her she did not deserve to be a member of this board.
