**AGENDA ITEM:** Consider Approval of Purchase of Radio Communication System

**PRESENTER:** Dr. Derek Citty and Earl Husfeld

**ALIGNS TO BOARD GOAL(S):** Financial/Facilities – The District shall exhibit excellence in financial and facility planning, management, and stewardship.

### **BACKGROUND INFORMATION:**

- Per Board Policy CH (Local), any single, budgeted purchase of goods or services that costs \$50,000 or more, regardless of whether the goods or services are competitively purchased, shall require Board approval before a transaction may take place.

### **ADMINISTRATIVE CONSIDERATIONS:**

- The District's current radio communication system has been utilized by the District for several years. At this point in its life, the "coverage" and level of service that is being provided throughout the District is less than desirable.
- During the AISD 2025 Committee's review of the District's projected enrollment growth and immediate needs, the Safety/Security Sub-Committee discussed the need to replace the current radio communication system.
- The radio communication system and equipment being presented to you this evening takes advantage of current technologies and will provide much improved "coverage" throughout the District.
- To ensure the best pricing and value, the District utilized the TASB BuyBoard cooperative purchasing method to obtain the quote from Aerowave Technologies.
- In accordance with Board Policy CH (Local), the purchase/bid itemized on the following pages is presented for your review and consideration.

### **FISCAL NOTE:**

The cost of this purchase will be paid from available 2008 bond proceeds.

### **ADMINISTRATIVE RECOMMENDATION:**

The Administration recommends the Board of Trustees approve the purchase of a district-wide radio communication system and equipment from Aerowave Technologies in an amount not to exceed \$108,031.15.
