# **Extending End Date and Amendment Deadline for the** 2020-2023 ARP ESSER III Federal Grant

TEA has extended the end date of the 2020-2023 ARP ESSER III Federal Grant. The Notice of Grant Award (NOGA) currently reflects an end date of September 30, 2023. However, to incorporate the additional year of funding allowed by the Tydings Amendment, it has been extended to September 30, Ben Bolt-Palito Blanco I.S.D. Mail - Fwd: Extending End Date and Amendment Deadline for the 2020-2023 ARP ESSER III Feder... 2024.

Grantees do not have to amend their applications to receive their revised NOGA. Revised NOGA certificates can be accessed, viewed, and printed using the Document Library tab in eGrants. In the Search Criteria section, select School Year "2020-2021," Grant Program "2020-2023 ARP ESSER III Federal Grant Application," and Document Type "NOGA/NOGA E-mail," followed by the Search button.

## Extension of Due Dates for Amendments and Final/Revised Final **Expenditure Reports**

Because the 2020-2023 ARP ESSER III Federal Grant end date has been extended, the last amendment due date, final expenditure report due date, and revised final expenditure report due date are extended as follows:

Last Amendment Due Date	July 2, 2024
Final Expenditure Report	January 2, 2025
Revised Final Expenditure Report	January 2, 2025
