**RESOLUTION ESTABLISHING DATES  
FOR FILING AFFIDAVITS OF CANDIDACY**

BE IT RESOLVED by the School Board of Independent School District No. 199, State of Minnesota, as follows:

1. The period for filing affidavits of candidacy for the office of school board member of Independent School District No. 199 shall begin on July 14, 2026 and shall close on July, 28, 2026. An affidavit of candidacy must be filed in the office of the school district clerk and the \$2 filing fee paid prior to 5:00 o'clock p.m. on July 28, 2026. **Please note:** The District Office is closed at 12:00 o'clock p.m. on Fridays during the filing period. Candidates should plan accordingly when submitting affidavits. The terms of three current School Board members will expire at the end of December, 2026.

2. The clerk is hereby authorized and directed to cause notice of said filing dates to be published in the official newspaper of the district, at least two (2) weeks prior to the first day to file affidavits of candidacy. Publication of said notice prior to the date of adoption of this resolution is hereby ratified and approved in all respects.

3. The clerk is hereby authorized and directed to cause notice of said filing dates to be posted at the administrative offices of the school district at least ten (10) days prior to the first day to file affidavits of candidacy.

4. The notice of said filing dates shall be in substantially the following form:

NOTICE IS HEREBY GIVEN that the period for filing affidavits of candidacy for the office of school board member of Independent School District No. 199 shall begin on July 14, 2026, and shall close at 5:00 o'clock p.m. on July 28, 2026. **Please note:** The District Office is closed at 12:00 o'clock p.m. on Fridays during the filing period. Candidates should plan accordingly when submitting affidavits.

The general election shall be held on Tuesday, November 3, 2026. At that general election, three individuals will be elected to fill vacancies on the School Board for a term beginning on the first Monday of January, 2027 and expiring on the first Monday in January, 2030.

Affidavits of Candidacy are available from the school district clerk, Independent School District No. 199, 2990 80th Street E., Inver Grove Heights, MN 55076. *Note: The District Office is closed at 12:00 o'clock p.m. on Fridays during this filing period.* The filing fee for this office is \$2. A candidate for this office must be an eligible voter, must be 21 years of age or more on assuming office, must have been a resident of the school district from which the candidate seeks election for thirty (30) days before the general election, must have no other affidavit on file for any other office at the same election, and must meet any other qualifications for this office prescribed by law.

The affidavits of candidacy must be filed in the office of the school district clerk and the filing fee paid prior to 5:00 o'clock p.m. on July 28, 2026. All affidavits have a two-day withdrawal period after the deadline. The final date of withdrawal is prior to 5:00 pm on July 30, 2026.
